## APPENDIX REGISTER APPLICATION FORM

Applicant(s) must be current **paid up members** of KUSA

**Microchip & DNA Profile Typing Certificate** obligatory (Attach to application form)

**Breed Evaluation Form** signed by **two appointed judges** (Attach to application form)

Breeds listed in **Schedule 2, Appendix C**, must meet the breed specific registration requirements specified if wish to register the progeny.

Appendix Register dogs cannot bear a Kennel Name other than that of the breeder.

### **Appendix Register – Level 1 Imported dogs and their progeny.**

This register is for imported dogs of breeds still to be recognised by KUSA & FCI.

For recognised breeds coming from countries with which KUSA has no reciprocity agreement.

For recognised breeds registered on an Appendix Register with a registry with which KUSA has a reciprocity agreement.

For imported dogs with an incomplete 3 generation pedigrees issued by a registry recognised by KUSA.

Progeny may progress to the Primary Breed Register after four generations- all ancestors listed on the 3 generation pedigree must bear KUSA registration numbers.

May enter Breed Classes at Championship and Non Championship KUSA Licensed shows but not eligible for Breed Champion status.

Not eligible for FCI CACIB.

### **Appendix Register- Level 2 Dogs bred in KUSA jurisdiction registered with a non-recognised dissident registry.**

This register is for recognised breeds, bred in South Africa, with Pedigree issued by a registry not recognised by KUSA for which no reciprocity agreement exists.

Progeny not eligible for registration on Primary Breed Register until all criteria met.

Progeny may progress to the Primary Breed Register after four generations- all ancestors listed on the 3 generation pedigree must bear KUSA registration numbers.

May enter Breed Classes at Championship and Non Championship KUSA Licensed shows but not eligible for Breed Champion status.

Not eligible for FCI CACIB award.

### **Appendix Register – Level 3 Dogs bred in KUSA jurisdiction where ancestry is unknown and unverifiable.**

This register is for recognised breeds, bred in South Africa, with complete or incomplete Pedigrees issued by a registry not recognised by KUSA or where it can be shown that one or more ancestor in the previous three generations was registered with KUSA as a purebred.

Progeny not eligible for registration on the Primary Breed Register.

Progeny may only progress to the **Appendix Register Level 2** from the 4<sup>th</sup> generation – complete 3 generation ancestry -all bearing KUSA registration numbers if a Breed Evaluation is done and the two appointed judges agree that the dog is true to the Breed Type.

May only enter Breed Classes at Non- Championship shows and not eligible for Breed Champion status.

Not eligible for entry to FCI CACIB Shows.
