## **REGULATIONS FOR THE KUSA WINNERS SHOW - (ZAW)**

### **(Breed & Handling only)**

#### **Schedule 05E (23)**

(Effective 1.02.2017)

Regulations for the Kennel Union of Southern Africa KUSA Winners Show

#### **1. LICENSING & SHOW REGULATIONS**

The Regulations relating to licensing and all other matters to do with Shows as set out in Constitution and Schedules of The Kennel Union of Southern Africa (KUSA) shall apply to this competition so far as they can be relevant to KUSA Winners Show and do not conflict with the specific terms of this Schedule 5E (23).

#### **2. SCOPE OF THE LICENCE**

This event will be licensed in terms of Article 30 of The Kennel Union Constitution.

#### **3. ELIGIBILITY OF DOGS FOR COMPETITION**

Any dog may compete in any section of this event to which it is entitled provided that it is registered with The Kennel Union of Southern Africa (KUSA) in the Breed Register; or registered in the Appendix/Development Register, and whose eligibility is not in conflict with the Regulations hereunder described or has not been disqualified or suspended from competition by The Kennel Union of Southern Africa (KUSA) or any other National Canine Control Body. No dog may be entered into this competition if it is not registered or recorded with Kennel Union of Southern Africa (KUSA).

#### **4. VENUE AND DATE FOR FUTURE YEARS**

The venue shall be such venue as the Executive Council of the Kennel Union of Southern Africa (EXCO) shall determine, from time to time and the event shall be held over weekend twenty-two (22), unless determined otherwise by EXCO. It shall be a neutral centre for award purposes.

#### **5. QUALIFICATIONS FOR ENTRY**

##### **5.1 Breed**

Open to all dogs on the KUSA Breed, Appendix and Development Registers.

##### **5.2 Handler**

5.2.1 Open to Child Handlers – over 8 and under 11 years

5.2.2 Open to Junior Handlers – over 11 and under 18 years

#### **6. CONDITIONS OF ENTRY**

All entries must be submitted on a current KUSA entry form.

## **7. DETERMINATION OF WINNERS**

The show will be run as a normal Championship Show as determined under KUSA Schedule 3 and will be a paid entry.

### **7.1 Breed Classes**

7.1.1 All Best of Breed winners will be awarded the title KUSA BREED WINNERS (year) and this will be recorded on the dog's Registration document, (pedigree) e.g. ZAW'15.

### **7.2 Handler**

7.2.1 Child Handler. The winner of this event shall be declared to be: KUSA WINNERS CHILD HANDLER (Year).

7.2.2 Junior Handler. The winner of this event shall be declared to be: KUSA WINNERS JUNIOR HANDLER (Year).

## **8. JUDGING**

All Judges must be fully qualified to judge the event for which they are appointed.

## **9. FOREIGN JUDGES**

No foreign Judge may judge any event unless he has the minimum qualifications required for domestic Judges for that event by KUSA.

## **10. SPONSORSHIP**

The event may be sponsored by any organisation acceptable to the Federal Council of The Kennel Union of Southern Africa (FEDCO). In the years when the event is sponsored, the title may be preceded by the name of the Sponsor. Should either KUSA or Sponsor wish to disassociate themselves with the event, this may not be done so as to prejudice the holding of the event in that year or any succeeding year. For this reason a contract must be drawn up between KUSA and any Sponsor establishing the rights and obligations of both should either or both wish to withdraw from associating this competition.
