NON-REGISTRY BREED LISTING GUIDELINES

Definition of the dogs which will fall within the Non-registry Breed Listing (AB).

- A local registry not recognised by KUSA but where the dog is deemed to be of pure breeding. Dogs with complete or incomplete pedigrees issued by a non-official (for commercial purposes) registry (E.g., SACBR; CanineSA; NDBC; SADBA & "Lost dogs") Ancestry will be reflected on the Non-registry Breed Listing Certificate as NOT VERIFIED. E.g.," 0010101 (Not Verified)" "BS9876 (Not Verified)"
- 2. Dogs without pedigrees but deemed to be pure bred and true to breed type
- Dogs from a non-recognised Club from a country where there is an FCI Member or Registry with which KUSA has a reciprocity agreement - will be accepted as a single dog application however no ancestry/ genealogy will be recorded on the Non-registry Breed Listing Certificate. (Parentage will be recorded as Unknown)

<u>Criteria for acceptance on Non-registry Breed Listing (AB). (Single Dog Application)</u>

- 1. Must have a microchip identification
- 2 Dog to be evaluated true to Breed type by one (1) KUSA appointed Judge, who must scan and verify the microchip number of the dog evaluated. Breed Evaluation Form signed by the KUSA appointed Judge is mandatory. [Breed Evaluation Form on KUSA Website – https://kusa.co.za/index.php/kusa-members/fees-forms/misc-forms]
- 3. Where a particular Breed has Breed Specific Registration requirements listed under Schedule 2 (Appendix C) these requirements must be met [. E.g., Biewer Terrier DNA Parentage Verification.]
- 4. A KUSA imposed Breeding Restriction will be placed on the dog = "Not authorised for Breeding*"
- 5. Other notations to appear on the Non-registry Breed Listing Certificate: "Progeny N/E for Primary Breed Register".
 - "N/E Breed Champ Status"
 - "Not Eligible –Export Pedigree"
- 6. The Owner of the dog must be informed in writing of the KUSA imposed Breeding Restriction, the lifting of which is at the sole discretion of KUSA, after evaluation of all extenuating and extraordinary circumstances. Approval for the lifting of the KUSA imposed Breed Restriction must be attained **from Exco** prior to any mating taking place. Should approval for the lifting of the KUSA Breeding Restriction be granted, a DNA profile typing certificate will be required A KUSA imposed breeding restriction (Not authorised for Breeding*) will automatically be placed on all progeny / pups issued with a Non-registry Breed Listing Certificate.

<u>Litter registration criteria for Non-registry Breed Listing (AB).</u>

- Dogs recorded on the Non-registry Breed Listing (AB) may be bred to a Primary Breed
 registered dog (B), Breed Appendix Register (A) & (AA) or Non-registry Breed Listing (AB)
 dog where Exco has granted permission for the lifting of the KUSA imposed Breeding
 Restriction. Progeny remain on the Non- Registry Breed Listing (AB) until the criteria have
 been met for progressing to Breed Appendix Register (AA).
- A KUSA imposed Breeding Restriction will be placed on each of the pups with the Notation-"Not authorised for Breeding*" listed on the Non-registry Breed Listing Certificate.

- To register any progeny, will have to apply to Exco prior to mating to lift the KUSA imposed Breeding Restriction and both Dam & Sire must be DNA Profiled.
- The KUSA IMPOSED Breed Restriction will only be lifted after consideration of all
 extenuating and extraordinary circumstances and if deemed in the interest of improvement
 of the local gene pool of the Breed.
- All progeny / pups must be microchipped mating and lifting of KUSA imposed Breeding restriction would have to first have been approved by Exco
- Other notations to appear on the Non-registry Breed Listing Certificate:
 - "Progeny N/E for Primary Breed Register".
 - "N/E Breed Champ Status"
 - "Not Eligible -Export Pedigree"

Logo & Export Pedigree for Non-registry Breed Listing (AB)

- 1. No FCI Logo may appear on any Non- Registry Breed Listing Certificate (AB)
- 2. Not eligible for issue of an Export Pedigree.

Showing allowances:

- 1. KUSA Shows / Events
 - a. May be shown at Breed Non-Championship Shows only
 - b. Depending on the regulations for other Discipline events, Non-registry Breed Listing (AB) dogs may compete in other licensed Discipline events and receive awards.
- 2. FCI Shows/ Events
 - a. Not eligible for competition.

<u>Criteria for progression from Non-registry Breed Listing (AB) to Breed Appendix</u> Register (AA).

Progeny may only progress to Breed Appendix Register (AA) upon written application. No automatic progression to Breed Appendix Register (AA). Only eligible to apply after the fourth complete (no missing) generation. The complete 3 generations of ancestry (Parents; Grand Parents; Great Grand Parents) must have been Listed or registered on the following:

- KUSA Primary Breed Register (B) and/or
- KUSA Breed Appendix Register (A), (AA) or Non- Registry Breed Listing (AB) and/or
- FCI or any other foreign recognised Kennel Club (Appendix or Breed Register)
- Progeny may only progress to Appendix Register (AA) upon submission of a written application and approval granted by Exco.
- Application for registration of progeny on Breed Appendix Register (AA) must include:

Breed Evaluation Form signed by one (1) KUSA appointed Judge declaring the dog to be true to breed type.[Breed Evaluation Form on KUSA Website - https://kusa.co.za/index.php/kusa-members/fees-forms/misc-forms]

The dog must be **over the age of 6 months** at the time the breed evaluation is conducted. The dog must be microchipped, and DNA profiled.
