

SCHEDULE 03

REGULATIONS FOR CHAMPIONSHIP SHOWS (1989)

(Effective 01.11.2026)

1. 1.1 The Executive Committee shall have the authority, delegated by the Federal Council to grant, withhold or cancel permission to hold any Show and to issue licences therefor in accordance with the Regulations relating thereto:
 - 1.2 **Championship Shows**
 - 1.2.1 Championship shows may be held by:
 - 1.2.1.1 All Breeds Clubs
 - 1.2.1.2 Group Clubs
 - 1.2.1.3 Specialist Clubs
 - 1.2.1.4 Specialist Multi-breed Clubs
 - 1.2.1.5 Clubs being neither All Breeds Clubs, Group Clubs nor Specialist Clubs that were accorded Championship status prior to 1 September 1975, provided that they are qualified to hold a Championship Show.
 - 1.2.2 To retain Championship status the following shall apply:
 - 1.2.2.1 All-breeds Clubs - no minimum number of dogs entered or additional Show Entry Fees are required.
 - 1.2.2.2 Group Clubs – a minimum of forty (40) exhibits entered for the Show or, when fewer than 40 (forty) exhibits are entered, the Club shall be liable to pay KUSA Show Entry Fees equating to 40 (forty) exhibits.
 - 1.2.2.3 Specialist Multi-Breed Clubs and Specialist Clubs – a minimum of twenty (20) exhibits entered for the Show or, when fewer than 20 (twenty) exhibits are entered, the Club shall be liable to pay KUSA Show Entry Fees equating to 20 (twenty) exhibits.
 - 1.2.2.4 Clubs contemplated in Regulation 1.2.1.5 above – a minimum of twenty (20) exhibits entered for the Show or, when fewer than 20 (twenty) exhibits are entered, the Club shall be liable to pay KUSA Show Entry Fees equating to 20 (twenty) exhibits.
 - 1.2.3.1 It is not compulsory for a Club qualified to hold a Championship Show or to hold one (1) in each calendar year.
 - 1.2.3.2 Whenever a Club, for whatever reason, becomes unqualified to be issued with a Championship Show licence, it may seek re-qualification for a Championship Show licence by holding a Re-qualifying Show.
 - 1.2.3.3 Whenever a Club elects not to hold a Championship Show for two (2) successive years, or longer, it shall be obliged to hold a Re-qualifying Show at which the minimum number of dogs required to be entered and present – i.e. forty (40) at a Group Club and twenty (20) at a Specialist or Specialist Multi-breed Clubs – shall be the qualifying criteria for regaining Championship status.
 - 1.2.3.4 In those years where a Championship Show-holding Club elects not to hold a Championship Show, and in any year it holds a Qualifying Show, in terms of Regulation 1.2.3.2 or 1.2.3.3, it shall remit the Affiliation Fee of a Championship Show-holding Club.
 - 1.3 The number of dogs present and exhibited at any Non-Championship Show, save and except a Qualifying or Requalifying Show, shall not affect any requirements to obtain or retain Championship Show status.
 - 1.4 Any Club seeking qualification or re-qualification for a Championship Show licence and relying upon the number of dogs present and exhibited at a Qualifying or Re-qualifying Show, shall arrange for a Kennel Union Representative to be appointed who shall act in terms of Regulation 4.1 hereof and, in addition, shall report specially on the number of dogs present and exhibited at such Show.
 - 1.5 Nothing in this Regulation shall be construed to mean that the minimum number of exhibits present and shown at a Qualifying or Re-qualifying Show shall be the sole criterion on which the Club will be assessed for compliance and on which the issuing of a subsequent Championship Show licence will be based.
2. Every application for a licence to hold a Championship Show shall be made not less than six (6) calendar months for Shows held from 1 January 2003 before the proposed date, on an official Kennel Union form, signed on behalf of the applicant Club by the Chairman, Treasurer and Secretary, who shall give their full addresses, setting out the information required therein, and such application shall be accompanied by the draft schedule of the Show, a letter of acceptance from each prospective Judge and the fee prescribed in terms of Schedule 07.

- 2.1 Unless dispensation is granted by the Executive Committee, no Championship Show shall exceed two (2) days duration and no Championship Show shall be held outside the Centre in which the show-holding club is domiciled.
- 2.1.1 Notwithstanding Regulation 2.1 above, if the Club is a standalone Specialist Breed Club (the sole Club for a particular breed affiliated to KUSA), it may apply to the Executive Committee, as contemplated in Article 29.2, to hold its annual Championship Show in a Centre other than that in which it is domiciled, or to hold an additional Championship Show in such other Centre in the same year. In adjudicating either application, the Executive Committee shall take into account the geographical distribution of exhibitors, logistical factors and the overall benefit for the breed concerned, on the strict understanding that no licence shall be granted to a Specialist Breed Club to hold its Annual Championship Show in another Centre for two or more consecutive years.
- 2.1.2 In this context and for better administration by the Kennel Union, the area of Southern Africa falling under its jurisdiction shall be divided into geographical Centres as follows:
- Gauteng
KwaZulu-Natal
Free State
Northern Cape
Eastern Cape
Western Cape
Mpumalanga
Limpopo
North West
Namibia
- and such additional Centres as defined by the Federal Council from time to time in accordance with the provisions of the Constitution of KUSA.
- 2.1.3 Void
3. The Show licence application, signed by the officers of the applicant Club, shall constitute an undertaking given by each of them binding themselves jointly and severally to hold and conduct the Show under and in accordance with the Regulations of the Kennel Union, to guarantee the payment of all prize monies and to submit to and adopt any decision of the Federal Council or any Provincial Committee, or Liaison Council to which the Federal Council may delegate its powers.
- 3.1 Such application referred to in Regulation 3 shall also constitute an agreement by such officers and each of them that any decision given against them or any of them under Rule 2 of the Disciplinary Rules (Schedule 01) may be communicated by the Secretary to the Secretaries of all Affiliated Clubs and governing bodies in reciprocity with or recognised by the Kennel Union and may also be published in the Official Kennel Union Journal, together with a report of the proceedings of the matter, including names, addresses and descriptions.
- 3.2 Any notice sent by email to any of such officers sent to the email addresses given in the application shall be deemed full and sufficient notice to them or any of them of any proceedings, matters or decisions of the Federal Council or Executive Committee or relating to the conduct of the Show or in respect of any other matter whatsoever arising out of or in connection with such Show.
- 3.3 Notwithstanding, and in addition to the provisions of the Disciplinary Rules in Schedule 01, the Executive Committee shall have power to impose a fine upon any Club, the officers or members of which have, in the course of conducting a show, breached these Regulations.
- 3.4 The management of a Breed Show shall be the responsibility of the Show Manager who shall be a member in good standing of the Kennel Union and appointed by the Committee of the Show holding Club.
- 3.5 Every Show shall be deemed to have started two (2) hours before the time judging commences, as advertised on the show schedule. Every Show shall be deemed to have closed one (1) hour after completion of the judging or of the event as the case may be.
- 3.6 The applicant Club may make a decision to lend a licence to the organisers of the event, in which case that organising committee will be held responsible under Regulation 3 and Sub-Regulations 3.1 to and including 3.5 above. An agreement between the two parties must be submitted, together with the application for the licence from the applicant Club on a form specified by the Kennel Union Office.
4. The Federal Council, the Executive Committee, the Secretary of the Kennel Union, or any Provincial or Liaison Council or Breed Council Executive may appoint a person to be the Kennel Union Representative who, at the time of his undertaking an appointment, shall be a member of the Kennel Union in good standing to attend any Championship Show, whose function shall be to observe that the Show is conducted properly in terms of these Regulations.

- 4.1 Any show holding Club may also request that a Kennel Union Representative be appointed by submitting a request in writing to their Provincial Council.
- 4.2 Every Kennel Union Representative shall be required to submit a written report to the Kennel Union within fourteen (14) days of the close of the Show he attended in such capacity, reporting on the procedure, conduct and management of such Show, with special reference to observance of Regulations for Championship Shows. A KUSA Representative may not enter, exhibit or handle a dog registered in his name at any KUSA licensed event held at the same venue on the day that he is officiating, nor in the same discipline held under the same licence on any day.

5. **SHOW SCHEDULES**

The official Schedule of any Championship Show shall display the KUSA Logo in a format, version and size specified by the Kennel Union office. If published in the Official Kennel Union Journal, the official Schedule may omit the following provisions of this Regulation 5, sub-paragraphs 5.2, 5.4, 5.8, 5.8.1, 5.8.2, 5.8.3, 5.8.6, 5.8.7, 5.12 and 5.13; whereas the official Schedule sent to the Kennel Union for approval and subsequently distributed direct to potential exhibitors by the show-holding club shall contain *inter alia*:

- 5.1 the names of the Club's Officers
 - 5.1.2 venue
 - 5.1.3 date of the show
- 5.2 the classification of breeds which may be exhibited, subject to such classification being in accordance with the Regulations set out in Schedule 02 (Regulations for the Classification, Registration and Transfer of Registered Ownership of Dogs).
 - 5.3.1 the names of the Judges of each breed, the groups and variety classes and Best in Show
 - 5.3.2 the names of each Registered Helper [IGP]
- 5.4 the definitions of classes for which competition is offered, subject to all such definitions being in accordance with Appendix 1 to these Regulations
 - 5.5.1 the order in which the Best in Group classes and Best in Show classes will be judged
 - 5.5.2 the amount of entry, benching and other fees
- 5.6 the trophies, special prizes and prize money offered with conditions of competition therefor and the names, if any, of guarantors of prizes
- 5.7 Whether the award certificates on offer at the Show will be issued in hard copy, or made available digitally for download by exhibitor
- 5.8 the conditions under which dogs are eligible to compete for Group Challenges and Best in Show
- 5.9 the following notices to Exhibitors:
 - 5.9.1 puppies under four (4) months are not eligible for exhibition.
 - 5.9.2 a dog is not eligible for entry in variety classes unless also entered and exhibited in a breed class, except a veteran, which may be entered in any Variety Veteran Class
 - 5.9.3 in estimating the number of prizes won, wins in Variety, Minor Puppy and Baby Puppy Classes, shall not count for entry in breed classes and wins at Non-Championship Shows and Match Meetings do not count, and wins at Championship Shows awarded after the date of entry to the instant Show do not count.
 - 5.9.4 the mating of bitches within the precincts of the Show is forbidden
 - 5.9.5 whether or not bitches in season are admitted for exhibition or competition
 - 5.9.6 for exhibition only, all exhibits must be entered in at least one (1) Breed Class
 - 5.9.7 conditions attracting immediate disqualification are set out in Regulations 7 and 31 of this Schedule.
 - 5.9.8 save for the Breed Classes offered at Specialist Club Championship Shows, all dogs entered and exhibited at Championship Shows must be registered in the ownership of members of the Kennel Union
- 5.10 All notices of forthcoming Championship Shows which are published by affiliated clubs shall contain a statement that all exhibitors/handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. Such notice shall be prominently displayed at the venue on the day of the show in such a manner and in such places so as to ensure that any person entering the venue will see the said notice.
 - 5.11.1 The time by which dogs are required to be present.
 - 5.11.2 The time judging is to commence and the proposed order of judging (where this differs from the order of breeds listed in Schedule 02 Appendix 'A1' and 'A2'), shall be clearly indicated on the Show Schedule.

- 5.12 The closing date for acceptance of entries.
- 5.13 A separate entry form, which must be in accordance with the approved form, a specimen of which is available from the Secretary.
- 5.14 In those Schedules which list Obedience Classes and Working Trials, in addition to Breed Classes, the following notice to exhibitors:
A dog is not eligible to compete in any Obedience Class or Working Trial notwithstanding having been correctly entered therefor unless such dog's record card is presented to the Judge of such Class or Trial before judging commences.
- 5.15 Whenever a Show Committee reserves the right to cancel or amalgamate classes, amend the prize list, or to return entries, prominent notice thereof shall be displayed in the Schedule and timeous notice of intention to exercise such right shall be given to exhibitors.
- 5.16 Where Draft Schedules submitted by Clubs in terms of Regulation 2 and Regulation 5 of this Schedule are:
 - 5.16.1 received by the KUSA Office later than six (6) months before the first day of the show, for any reason whatsoever, such Clubs shall pay Penalty Fees as specified for:
 - 5.16.2 each week or part thereof the Draft Schedule is received late, and/or
 - 5.16.3 each Judge who is not qualified to judge the Breeds/Groups/Events for which he has contracted himself.
- 5.17 Where a Club, for any reason whatsoever, has been unable to finalise its Draft Schedule twelve (12) weeks before the first day of the Show, no licence shall be issued for that event. If a licence has already been paid for, Licence Fees will be refunded to the Club, subject to the deduction of Penalty Fees incurred up to twelve (12) weeks and, should the Penalty Fees be in excess of the Licence Fees, the Club shall be responsible for payment of the shortfall.
- 5.18 When a Club fails to pay a penalty within sixty (60) days of the date of imposition the next application for a Licence for any Championship Show or Event submitted by that Club shall be refused until all outstanding Penalty Fees have been paid, provided that such payment is received not less than twelve (12) weeks prior to its Championship Show date.

6. **SHOW SCHEDULE**

No Show Schedule shall be issued to the public before being approved by the Executive Committee after submission in terms of Regulation 2, and within twenty-four (24) hours of issue to the public, a copy of the Show Schedules as so issued shall be dispatched to the Secretary.

- 6.1 The Schedule shall be treated as a contract between the Show Authorities and the Exhibitors. Once approved by the Executive Committee, no modification or amendment of any description may be made to the Show Schedule unless special dispensation is granted.
- 6.2 Any Club which fails to submit a Show Schedule in terms of Regulation 6 of this Schedule, shall pay a penalty as specified in terms of Subscription & Fees (Schedule 07).

7. **ENTRY FOR EXHIBITION**

Except as otherwise provided in the By-Laws applicable to a particular Discipline, only Members of the Kennel Union shall be entitled to enter and have dogs in their registered ownership compete in any Championship Dog Show, Championship Obedience Class, Championship Working Trial, Field Trial Championship Open Stake or Field Qualifier or any other Championship event, licensed by the Kennel Union, save for Breed Classes offered at Specialist Club and Specialist Multi-breed Club Championship Shows, where entries will also be open to non-members' dogs, with the exception of dogs in the registered ownership of persons on whom *persona non grata* status has been imposed, such dogs not being eligible for exhibition at any KUSA-licensed event.

All entries shall be submitted on an Official Show Entry Form (which includes the approved online electronic version thereof), fully completed and signed or, in the case of an online electronic entry, by acceptance of the Declaration. Any alteration or amendment to the Declaration on either version of the Official Show Entry Form shall invalidate the entry. The current Official Show Entry Forms shall be those appended to this Schedule as Appendix 3 and are the only valid forms for Show Entry purposes.

Entries must not close before the date indicated on the Show Schedule which shall not be less than three (3) days and not more than thirty (30) days before the Show opens.

- 7.1 The Show Secretary shall be held responsible for reporting any known violation of Regulation 7, which may be dealt with under Schedule 01 Rule 2.
 - 7.1.1 When an entry is submitted to a show holding Club, the Registered Owner(s) declared on the Official Show Entry Form, shall be the Registered Owner(s) of the dog as recorded at the Kennel Union, or in a registry recognised via an agreement.
 - 7.1.2 No dog shall be accepted for entry in a Championship Show where the Registration Number of the dog is omitted from the appropriate section of the Entry Form. Insertion of the abbreviations "R.A.F." or "T.A.F." are not acceptable and will invalidate the entry.

- 7.2 In order to constitute a valid entry, the Registered Owner(s) or Authorised Agent of the dog shall submit a separate entry form for every dog entered by them, which shall be signed by the Registered Owner(s) or his/their Authorised Agent or, in the case of an online electronic entry, by insertion of full name and surname, and shall be accompanied by the correct and appropriate fees within the time limitation for the closing of entries.
- 7.2.1 In the case of a co-ownership, the full name of all the Registered Owner(s) must be stated and in the case of a dog being owned by a Limited Company, the Directors of the Company will jointly be considered as the Registered Owners of the dog for purposes of Show Entry.
- 7.2.2 In the case of a dog owned in partnership and entered in Member's Classes, each partner must hold membership of the Club.
- 7.2.3 There would be no objection raised where, in the case of a partnership, one partner is authorised to sign and in the case of a Limited Company, a nominee is appointed to sign, such authorisation and nomination to be advised to the Secretary.
- 7.3 All entry forms shall be preserved by the Show Committee for twelve (12) months from the last day of the Show.
- 7.4 No officer of the Show-holding Club shall complete any entry form, except his own nor shall he alter or amend any entry form after the entry has been made, nor shall he permit the alteration if or amendment of any entry form after the entry has been made save and except for the correction of bona fide errors by exhibitors in entries for the Baby Puppy, Minor Puppy, Puppy, Junior and Graduate Classes in respect of age determination where such errors are discovered by the officers of the Show-holding Club after acceptance of the entries.
- 7.5 No part of the Declaration of the Registered Owner/Authorised Agent as it appears on the official KUSA Show Entry Form may be deleted, redacted or amended so as to render such part not applicable for purposes of attestation and any such Show Entry Form must be discarded and the entry not accepted by the Show Secretary. Should the Show Secretary inadvertently accept such entry, the deleted, redacted or amended parts thereof shall remain in force and be regarded as binding on the Registered Owner/Authorised Agent.
- 7.6 A Show Committee may reserve the right to refuse any Show Entry and may exercise such right on good cause and reasonable grounds, but only insofar as it relates to any aspect covered in the Preamble of this Regulation 7, but shall act in strict adherence to any restriction imposed by the Executive Committee on the acceptance of Show Entries for a particular dog received from Registered Owners, Authorised Agents or any other persons, in accordance with Regulation 33.4, as duly advised to Clubs by the KUSA Office. Such restriction shall remain valid until the lifting thereof has been advised by the KUSA Office on behalf of the Executive Committee.
- 7.7 For the purposes of making an entry in estimating the number of prizes won, wins in Variety, Baby Puppy and Minor Puppy Classes do not count for entry in Breed Classes, wins at Non-Championship Shows and Match Meetings do not count, and wins at Championship Shows awarded after the date of entry do not count.
- 7.8 Within fifteen (15) working days after the completion of a Show, the Show Secretary shall forward to the Secretary a list showing the total number of dogs entered and the total entries, together with fees as specified in Subscriptions and Fees (Schedule 07). After a period of two (2) months from the completion of the Show, a complaint may be lodged by the Secretary against the Club for non-compliance.
- 7.9 No person representing the Kennel Union in terms of Regulation 4 may enter, exhibit or handle a dog for competition.
- 7.10 Entry by Judges
- 7.10.1 A Judge may only enter and/or handle a dog in accordance with the Regulations below. If transgressed, automatic disqualification of the dog(s) will apply and the Judge may be liable for disciplinary action under Schedule 01.
- 7.10.1.1 Breed Judges – A Judge may not enter a dog registered in his ownership in the same discipline at the same Championship Show, under the same licence, as he is officiating. For the avoidance of doubt, an officiating Judge may enter the same discipline, at Championship Shows, at the same venue on the same day held under a separate licence.
- 7.10.1.2 Dogsport Judges – A Judge may not enter a dog registered in his ownership in the same discipline at the same Championship Show, under the same licence, as he is officiating, unless specifically permitted by the relevant Dogsport Schedule.
- 7.10.2.1 Breed Judges – A Judge may not handle a dog registered in his ownership in the same discipline at the same Championship Show, under the same licence, as he is officiating. For the avoidance of doubt, an officiating Judge may handle a dog registered in his ownership, at Championship Shows, at the same venue on the same day held under a separate licence.
- 7.10.2.2 Dogsport Judges – A Judge may not handle a dog registered in his ownership in the same discipline at the same Championship Show, under the same licence, as he is officiating, unless specifically permitted by the relevant Dogsport Schedule.
- 7.10.3 A Judge, appointed to judge Junior Showmanship only, may enter a dog registered in his ownership in Breed and Dogsport, and may handle any dog in Breed and Dogsport, on the same day at the same venue, under the same or different licence, as he is officiating.

- 7.11 No Ring Steward may handle a dog on the same day as he is officiating before a Judge for whom he was stewarding unless requested by the Judge to exhibit the entry. Automatic disqualification of the dog(s) will apply and the Ring Steward will be liable for disciplinary action under Schedule 01.
- 7.12 Any exhibitor who enters a dog after disqualification under Regulation 32 is liable to disciplinary action under Rule 4, Disciplinary Rules (Schedule 01).
- 7.13 Any entry form shall be forwarded to the Secretary whenever called for within twelve (12) months from the last day of the Show.
 - 7.14.1 In the case of German Shepherd Dogs, in order to constitute a valid entry, at a Specialist Show, the dog's microchip number must be entered on the Show Entry Form.
 - 7.14.2 In the case of Rottweilers entered at Specialist Club Shows, all exhibits are to be positively identified by microchip in the marshalling area before entering the ring.
- 7.15 Any dog which has been exhibited contrary to these Regulations shall be liable to disqualification and cancellation of any awards gained, whether or not an objection has been lodged under Regulation 31.

8. **EXHIBITS ONLY AT SHOW**

No animal other than an exhibit entered for competition or for exhibition only, shall be allowed within the precincts of a Show, except a registered Guide Dog for the Blind or hearing dog for the deaf or dog requested for educational or instructional purposes or by permission of the Show Committee of the Show-holding Club.

9. **HEIGHT AND WEIGHT CLASSES**

- 9.1 Whenever competition is subject to compliance with a height limit, the Show Committee shall provide a properly constructed measuring stick or alternative measuring device. Whenever a Judge calls for a measurement to be taken, the exhibit shall be measured by the Judge while it is standing on a firm, level surface within the show ring. If the exhibit fails to comply with the height limitation to which it is subject, the Judge shall mark his judging sheets accordingly and taking into consideration the requirements of the Breed Standard, make such award as he thinks proper. Failure to comply with the height limit shall not disqualify a dog nor render it ineligible for further competition except where specified in the Breed Standard. In the case of dispute, the decision of the Judge shall be final.
- 9.2 Whenever competition is subject to a desired weight limit, the Show Committee shall provide a weighing instrument and weights (if not electronic), for which a valid certificate of assize is available, for recommended use by the Judge. At the discretion of the judge, before the commencement of judging of each class, the dogs entered in that class shall be weighed by the Judge on a firm, level surface within the show ring. If any exhibit fails to comply with the desired weight limitation required by the Breed Standard, the Judge shall mark his judging sheets accordingly, and, taking into consideration the requirements of the Breed Standard, make such awards as he deems appropriate. In making his awards, the Judge shall have the utmost regard for the preservation of breed type of breed varieties separated by desired weight limitations and take into account factors like conformation to the Breed Standard, general physical condition and marginality of weight deviation.

10. **SHOW CATALOGUE**

The Show Committee shall publish a Show Catalogue which shall contain entries similar to those Regulations 5.1, 5.3 and 5.6 and full particulars of the entry of each exhibit, including the dogs' microchip numbers and the names of their Registered Owners, as recorded on the Show Entry Form. Show Catalogues shall be neither handed out, nor made available digitally to any person, entity or grouping for any purpose whatsoever prior to the official start of the Show as contemplated in Schedule 03 Regulation 3.5. Show catalogues shall not be published on any public forum or on any social media platform and digital distribution shall be strictly confined to closed groupings of exhibitors entered for a particular Show, which shall exclude officiating Judges, and such distribution shall not take place prior to the official start of the Show as per Schedule 03 Regulation 3.5.

- 10.1.1 The name of the KUSA Representative.
- 10.1.2 The order in which the Best in Group classes and Best in Show classes will be judged
- 10.2 In addition to the provisions of Regulations 10 and 10.1 above, the Show Committee may accept and publish any advertising or other matter within the catalogue and may charge such price for each catalogue as it shall decide.
- 10.3 One (1) copy of the catalogue containing accurate details of all show entries and all awards made, signed and certified as correct by the Show Secretary shall be despatched to the Secretary within fifteen (15) working days after the close of the Show.
- 10.4 Any Club which fails to submit a catalogue in terms of Regulation 10.3 of this Schedule such Club shall pay a penalty as specified in terms of Schedule 07 for each week or part of a week thereof that such catalogue is not received.

11. DISINFECTION AND SANITATION

The Show Manager and Show Committee shall ensure that Schedule 09, Regulation 2.7 is complied with.

- 11.1 Any person leaving a benching, grooming or ringside area in a dirty or unsanitary condition may be dealt with in terms of Regulation 37.3.

12. LICENCES

12.1 All licences shall be signed as approved by the issuing authority.

12.2 All licences issued shall include *inter alia* the date/s upon which each event for which the licence is issued is to be held and the venue of such event.

12.3.1 Where a licence issued to an Affiliated Club is for a show or event to be held on one (1) day only, such Show or event shall be considered to be closed and concluded one (1) hour after the completion of the last event for which licence was issued.

12.3.2 Where a licence issued to an Affiliated Club applies to events held on more than one date, each event listed on such composite licence shall be considered closed and concluded one (1) hour after completion of the judging or completion of the event, as the case may be, on the particular date/s as indicated on the licence.

12.4.1 When more than one type of event is listed on a licence issued by the Kennel Union to an Affiliated Club, for the purposes of Regulation 2.1 only, each event listed shall be treated as though it were a separate show and shall not exceed two (2) days duration and no event held under such composite licence shall be held outside the Centre in which the show holding club is domiciled.

12.4.2 Where any club applies to the Executive Committee for dispensation to hold an event outside its area of domicile and such dispensation is granted, a separate licence shall be issued therefor.

13. VETERINARY EXAMINATION

At least one (1) qualified Veterinary Surgeon shall be appointed who shall be available to attend the Show within a reasonable time upon being requested to do so in order:

13.1 to ensure that no dog is suffering from any condition which renders it undesirable to be exhibited; or

13.2 to examine and report upon any dog during the Show at the request of the Judge or the Show Committee or its authorised Show Manager; or

13.3 to attend to any dog which, for any reason, appears to require veterinary attention.

14. EXCLUSION OF DOGS

A Show Committee will have the power to exclude, refuse or remove any dog which is, owing to disease, savage disposition, or any other cause, not in a fit state for exhibition at a specific Show. Once a dog has been excluded or refused admission or has been removed from the precincts of a Show because of disease, savage disposition or any other cause, it will not be brought into the Show at any time or under any circumstances. The Show Secretary, on behalf of the Show Committee, shall submit to the Secretary within seven (7) days of the close of the Show a written report supported by sworn statements of any witnesses and all other evidence available to the Show Committee at the time of the incident following the procedures as set out in the Temporary Exclusion Order Manual and Annexure A thereof published from time to time by the Federal Council.

14.1 In all cases of exclusion, witness statements gathered by the Show Secretary shall include sworn statements from either the Judge or the Ring Steward, if either had witnessed the incident which had caused the exclusion, or if details of the incident had come to their knowledge, irrespective of whether it had taken place inside the ring, or outside the ring.

14.2 On the receipt of a written report from a Show Committee, which has refused or excluded or removed any dog from the precincts of a Show, the Chairman of the Executive Committee shall, at his discretion, be entitled to temporarily order the exclusion of such dog from further entry to or exhibition at any Show held under Kennel Union Regulations, such temporary order to continue in force until the next meeting of the Executive Committee who shall, at such meeting, deal with the matter in accordance with the provisions of 14.4 hereunder.

14.3 The Secretary shall on the making of an order by the Chairman of the Executive Committee as provided for in Regulation 14.2 above, forward to the owner of the dog and all Provincial Councils, a copy of the temporary exclusion order and further inform such owner that he is entitled to submit a written representation supported by sworn statement/s of any witness/es and any other applicable evidence in this regard to reach the Secretary on a date which shall be not less than three (3) days before the date of the proposed next meeting of the Executive Committee.

- 14.4 The Executive Committee shall consider the report and supporting evidence of the Show Secretary as well as the written representation and supporting evidence of the owner of the dog, if any, and may order a further investigation into the incident before making a determination, or proceed and confirm the temporary exclusion of the dog and determine at its discretion any appropriate procedure to be complied with and/or tests to be taken in order to have the exclusion withdrawn and, at its sole discretion, withdraw all prizes and awards made to such dog at the Show where it was excluded from exhibition, following a similar procedure to that prescribed under Regulation 23, or withdraw the imposed temporary exclusion or, after due consideration, recommend to the Federal Council that the dog is not fit for exhibition and request that the dog be permanently excluded from exhibition. The determination of the Executive Committee of what constitutes appropriate procedures to be complied with and/or tests to be taken as well as the timeframes set therefor, for the purpose of these Regulations, shall be final and binding.
- 14.5 The Secretary shall, on the making of any decision, determination and/or recommendation by the Executive Committee as provided for in Regulation 14.4 above, forward to the owner of the dog a notice informing him thereof and, if applicable, of the timeframes set for the appropriate procedures to be complied with and/or tests to be taken. Upon receipt by the Secretary of sufficient proof of compliance with the conditions set by the Executive Committee, or in the absence of any proof provided within the allotted timeframe, the matter must be forwarded to the Executive Committee for consideration and final determination to either withdraw the temporary exclusion, or to make a recommendation to the Federal Council as provided for in Regulation 14.6 hereunder.
- 14.6 If, on recommendation of the Executive Committee, a dog is not fit for exhibition, the Federal Council shall be empowered to permanently exclude such dog from entry to, or exhibition at, any Show held under Kennel Union Regulations. In consequence of any decision reached under the provisions of Regulation 14, the Executive Committee shall be empowered to publish, on the Kennel Union's official website and Facebook pages, full details thereof and shall have the power to circulate this information to Affiliated Clubs and Provincial Councils.

15. EXHIBITION OF DOGS SUFFERING FROM CONTAGIOUS OR INFECTIOUS DISEASE

If any dog is exhibited which has been knowingly exposed to the risk of any contagious or infectious disease during a period of six (6) weeks prior to exhibition; or if any dog at a Show should be found to be suffering from any contagious or infectious disease, including any reaction to immunisation, or is found to be unfit for exhibition from any other cause, the exhibitor thereof shall be liable to be dealt with under Rule 2, Disciplinary Rules (Schedule 01).

16. EXHIBITION OF DOGS

- 16.1 No dog shall be allowed in the judging ring unless it is being judged or the exhibitor has been instructed to retain the dog in the ring pending judging of a subsequent class.
- 16.2 No dog shall be allowed to be off a lead or benching chain unless required by the Judge.
- 16.3 No handler of a dog shall exhibit on his person or upon the dog any prize, card or rosette, which may be displayed on the winning dog's bench only, save as permitted in Regulation 35.2 of this Schedule.
- 16.4 Limited and controlled attraction from outside the Judging Ring will be permitted under the following circumstances:
- 16.4.1. Limited to only one (1) person attracting any exhibit from outside the Judging Ring.
 - 16.4.2. Only noiseless objects shall be permitted to be used for purposes of limited outside attraction.
 - 16.4.3. Limited outside attraction shall only be permitted during the individual assessment of an exhibit by the officiating Judge and in the final assessment to place a Class, or to award a CC or Best of Breed. For the avoidance of doubt, limited outside attraction as contemplated in Regulations 16.4.1 & 16.4.2 hereof shall not be permitted during the judging of Group or Best in Show Challenges.
 - 16.4.4. No animals, whips, man-work or defence equipment shall be used for limited outside attraction.
 - 16.4.5. No running around the outside perimeter of the Judging Ring shall be permitted by a person attempting to attract an exhibit inside the ring.
 - 16.4.6. All limited outside attraction shall be entirely at the Judge's discretion and under the Judge's control and may be terminated by the Judge at any time or at any stage.
 - 16.4.7 Limited outside attraction must accord with accepted principles of good sportsmanship and in adherence to Schedule 09 – Code of Ethics for Members of KUSA – and be practised with due consideration for other exhibitors by not causing them or their dogs to be unduly distracted or disadvantaged.

[Note: Fedco 06-2026 Item 12.2.2 directs the amendments to Regulation 16.4 to be effective from 01.11.2026.]

- 16.5 No dog shall be allowed into the judging ring after having been called three (3) times by the Ring Steward and marked absent.

- 16.6 Once the Show Catalogue and the Judge's and Ring Steward's Sheets for a Show have been printed, no dog entered in a Class for which it is eligible shall be permitted to be moved to another Class for which it is eligible and any such request to the Show-holding Club in advance of the Show, or to the Ring Steward on the day of the Show, shall be denied.
- 16.7 No dog shall be entered in a Class for which it is not eligible and, should this occur, the dog shall be disqualified and any awards be withdrawn and, at the discretion of the Executive Committee, the Registered Owner be fined.
- 16.7.1 Should it be discovered by the Registered Owner/Authorised Agent before the commencement of judging of a particular Breed that a dog due to be exhibited in that Breed has been entered into a Class for which it is not eligible, the Registered Owner/Authorised Agent shall immediately report the erroneous entry to the Show Office. Regardless of culpability, if accepted to be a bona fide error, the Show Office shall issue a signed authorisation to the Ring Steward to amend the Judge's and Ring Steward's Sheets, which the Show Office shall request the Registered Owner/Authorised Agent to deliver to the Ring Steward.
- 16.7.2 Should it be discovered by the Registered Owner/Authorised Agent when judging of a particular breed has already commenced that a dog due to be exhibited in that Breed has been entered into a Class for which it is not eligible, the Registered Owner/Authorised Agent shall alert the Ring Steward, upon which judging shall be suspended to enable the Ring Steward to confer with the Show Office. Regardless of culpability, if accepted to be a bona fide error, the Judge's and Ring Steward's Sheets shall be amended by the Show Office, after which the Ring Steward shall return to the ring for judging to resume.
- 16.8 No dogs born or imported into the KUSA area of jurisdiction that have had their ears cropped after birth or importation, shall be eligible to compete in any Show or event licensed by the Kennel Union.
- 16.9 No dogs of which the ears were cropped prior to their importation into the Kennel Union area of jurisdiction shall be eligible to compete in any Show or event licensed by the Kennel Union, despite being eligible for registration by the Kennel Union in terms of Schedule 02 Regulation 7.2.
(Note: Leads/Leashes. The Federal Council resolved at the November 1998 meeting that in any KUSA document a 'lead/leash' refers to a lead/leash with a maximum length of two (2) metres (or approx. six and a half feet (6½')).

17. **USE OF SOUND AMPLIFIERS AND FIRE-ARMS**

The use of sound amplifiers or radios is forbidden at a Show, save and except at the discretion of the Show Committee.

- 17.1 The unauthorised use of fire-arms or the making of any noise at a Show which may be injurious or alarming to dogs is forbidden.
- 17.2 At any Show where a gunshot test is held such test must not interfere with Breed judging or Obedience Classes.

18. **WITHDRAWAL FROM COMPETITION**

- 18.1 Once a dog has entered the ring to be exhibited in one of the Classes for which he had been entered in advance of the Show, the dog shall be exhibited in all subsequent Classes entered and in all the Challenges and Competitions as contemplated by Regulations 21, 22 and 24 for which it has qualified at that Show. Failure to enter the ring when required to compete in subsequent Classes or Challenges and Competitions as described above shall, at the discretion of the Executive Committee, render the dog liable for disqualification and the cancellation of any awards gained, irrespective of any objection having been lodged in terms of Regulation 31.
- 18.2 Withdrawal from competition at the Show is only permissible
- 18.2.1 when the Judge listed in the Schedule is changed; or
- 18.2.2 when a dog's Owner or its Authorised Agent deems it necessary due to the dog's illness, injury or other legitimate reason, and in either of the above eventualities, the dog shall be marked as ABSENT on the Judge's and Ring Steward's Sheets.
- 18.3 Once a dog has entered the ring with the intention to be exhibited, it shall for purposes of these Regulations be deemed as having been exhibited and may not leave the ring before completion of the judging of that Class unless
- 18.3.1 the dog is excused or dismissed by the Judge for any reason whatsoever; or
- 18.3.2 the dog is withdrawn by the handler due to illness, injury, lameness, bad behaviour, or for any reason considered sufficient not to continue competing.
- 18.4 When a dog is excused or dismissed by the Judge, the Judge's and Ring Steward's Sheets shall be marked accordingly, e.g. DISMISSED/EXCUSED – LAMENESS, DISMISSED/EXCUSED – AGGRESSION, etc.
- 18.5 When a dog is withdrawn by the handler for any reason, the handler must inform the Ring Steward, after which the dog shall be marked as WITHDRAWN on the Judge's and Ring Steward's Sheets.
- 18.6 If a dog's withdrawal from further competition is forced by an emergency, domestic or otherwise, formal permission shall be granted at the sole discretion of the Show Manager, once he is satisfied that sufficient cause

has been shown why the dog should be withdrawn from further competition, after which the dog shall be marked as WITHDRAWN on the Judges' and Ring Steward's Sheets for the Class, Challenge or Competition from which the dog has been withdrawn.

- 18.7 For the avoidance of doubt, once a dog has, for whatever reason, been withdrawn, excused or dismissed from any one Class, Challenge or Competition, it shall not be permitted to compete in any further Classes, Challenges or Competitions at that Show.

19. JUDGING REQUIREMENTS AND REGULATIONS

- 19.1 All dogs exhibited shall be judged in suitable rings and all judging shall take place in public.
- 19.2 The Show Committee shall provide each Judge with judge's sheets in which the breed, class and exhibits' numbers only are entered.
- 19.3 Every Ring Steward and ring clerk shall be provided with a steward's sheet similar in content to the judge's sheets and no Show Catalogue shall be permitted within any judging ring. Judges officiating at a particular Show or KUSA-licensed event are not permitted to have access to a Show Catalogue and shall neither view, nor consult, such catalogue published or distributed in any format whatsoever, including but not limited to, on social media platforms, private chat groups, or forms of personal communication, whether inside or outside the judging ring, or before or during a judging assignment.
- 19.4 After the Judge has made his/her awards sequentially in order of merit 1 to 4 the Ring Steward will note the awards and announce them.
- 19.5 Any alteration made and initialled by the Judge in the judge's sheets shall be carried on to the office with other copies of judge's sheets.
- 19.6 In the event of a Judge making a report on any exhibit that has been improperly tampered with, is blind, deaf or suffering from contagious or infectious disease, the Show Secretary, shall cause such exhibit to be examined by the Veterinary Surgeon and submit the facts of the case to the Show Committee, which shall then act in terms of Schedule 03 Regulation 31.
- 19.7 Save and except for the necessary entry by any official of the show, and persons assisting disabled or wheelchair-bound handlers, the only persons permitted in the ring during judging shall be the Officiating Judge(s), Learner Judge(s), Steward(s), Ring Clerk/Secretary and the handlers of the exhibits being judged.
- 19.8 If a dog attacks a Judge or shows aggression towards a Judge, it must be immediately excused from the Ring and the Judge must immediately report the occurrence to the Show Manager. The Show Manager will then cause the dog to be withdrawn from all further competition in the Show. The Show Secretary shall then send a written report of the incident to the Secretary of KUSA in accordance with Regulation 14.

20. APPOINTMENT AND APPROVAL OF JUDGES, EVALUATORS AND FCI-IGP HELPERS

- 20.1 An Affiliated Club shall have unrestricted discretion to appoint its Judges who shall, if permanently domiciled in the KUSA area of jurisdiction, be members of the Kennel Union in good standing, both at the time of accepting an invitation and undertaking an appointment, subject to:
- 20.1.1 The Executive Committee's approval for every Judge elect shall be obtained in writing not less than six (6) months before the date of the show at which time the Secretary may notify the Club of any restriction imposed upon such Judge elect and any disqualification or suspension affecting the Federal Council's approval of appointment.
- 20.1.2 In the case of a Judge elect residing outside the jurisdiction of the Kennel Union, application for approval of appointment shall be made to the Executive Committee of not less than nine (9) months before the date of the Show.
- 20.2 Notwithstanding the provision of Regulation 20.1.1 and 20.1.2 the Executive Committee may grant special dispensation for a replacement Judge, Evaluator or FCI-IGP Helper to be appointed where a justifiable reason exists, such as illness, or a Judge's inability to travel.
- 20.2.1 In the case of a last-minute emergency necessitating the replacement of a Judge, Evaluator or FCI-IGP Helper, the Show Committee must seek the approval of the Chairman of the Executive Committee before appointing a replacement Judge, Evaluator or FCI-IGP Helper, also notifying the KUSA Office.
- 20.3 In the event of a Judge, having accepted an appointment, not fulfilling such engagement to judge, he shall be required to give his reasons in writing within seven (7) days to the Club Committee with whom he has been contracted and if such reason is considered to be unsatisfactory or if no such reason is submitted, the Club Committee shall request the Club Secretary or any other appointed member of the Club who is a member of the KUSA to submit a complaint to the KUSA in terms of Schedule 01 of the KUSA Constitution.
- 20.4 Making its arrangements in such a manner that no Judge shall be required to judge more than approximately 175 exhibits during any one day or not more than approximately twenty-five (25) dogs per hour.

21. CHALLENGE CERTIFICATES AND RESERVE CHALLENGE CERTIFICATES

- 21.1 On completion of the judging of all Classes up to and including the Open Class, which shall be the final Class

to be judged for purposes of awarding the Challenge Certificate, and which shall be judged before the Champions Class, all unbeaten Class winners of either sex, with the exception of the winners of the Baby Puppy Class, Neuter Dog Class and Champions Class, shall compete for the Challenge Certificate. Winners in one Class, but beaten in another, shall be deemed to be beaten dogs and ineligible to compete for the Challenge Certificate.

- 21.2 Once the Challenge Certificate has been awarded, the remaining exhibits shall compete against the runner(s)-up to the CC winner for the Reserve Challenge Certificate.
- 21.3 The awarding of the Challenge Certificate and Reserve Challenge Certificate shall be at the discretion of the Judge and, if no Challenge Certificate is awarded, no Reserve Challenge Certificate shall be awarded.
- 21.4 Challenge Certificates and Reserve Challenge Certificates signed by the Judge and Show Secretary or, when issued electronically, digitally system-signed and verifiable, shall be available to Exhibitors within thirty (30) days of the date of such award being made.
- 21.5 Every Challenge Certificate and every Reserve Challenge Certificate issued by the Kennel Union shall bear the following declaration: "It is my considered opinion that, unless ineligible to be awarded such title, this exhibit is worthy of qualifying for the title of Champion."
- 21.6 Challenge Certificates, where appropriate, shall bear a printed endorsement reading "2 points".
- 21.7 Challenge Certificates, where appropriate, shall bear a printed endorsement reading "1 point".
- 21.8 Whenever ten (10) or more dogs of one sex in a breed are exhibited, not necessarily in the same class, and all such dogs are eligible to compete for the Challenge Certificate and a Challenge Certificate is awarded, it shall be a "2 point" Certificate; in all other cases a "1 point" Certificate shall be awarded to the winner of the Challenge Certificate. In this context "exhibited" shall mean entry of the dog into the ring with the intention of being exhibited, irrespective of subsequent exclusion by the Judge, or withdrawal by the exhibitor, for any reason whatsoever.
- 21.9 Whenever twenty (20) or more dogs of one sex in a breed are exhibited, not necessarily in the same Class, and all such dogs are eligible to compete for the Challenge Certificate and a Reserve Challenge Certificate is awarded, the Reserve Challenge Certificate shall be a "1-point" Certificate; in all other cases, the Reserve Challenge Certificate shall not carry any point value. In this context "exhibited" shall mean entry of the dog into the ring with the intention of being exhibited, irrespective of subsequent exclusion by the Judge, or withdrawal by the exhibitor, for any reason whatsoever.
- 21.10 By applying his signature to Challenge Certificates and Reserve Challenge Certificates or, when these awards are electronically issued as digitally system-signed and verifiable Certificates, the Show Secretary assumes responsibility for the accuracy and validity of the Challenge Certificates and Reserve Challenge Certificates issued in confirmation of such awards made in terms of these Regulations. The responsibility to rectify any errors which might occur on Challenge Certificates and Reserve Challenge Certificates and to issue corrected Certificates either in hard copy or digitally, shall rest with the Show Secretary.

22. COMPETITION FOR BEST OF BREED, RESERVE BEST OF BREED, BEST PUPPY OF BREED AND OTHER BEST OF BREED CLASS AWARDS AND CERTIFICATES

- 22.1 On completion of judging of all breed Classes, excluding Baby Puppy and Neuter Dog, Best of Breed will be judged.
 - 22.1.1 Those exhibits eligible for the award of Best of Breed and Reserve Best of Breed, are both Challenge Certificate winners (provided they are unbeaten) and winners of the Champions Class (provided they are unbeaten).
 - 22.1.2 Whenever a Challenge Certificate is awarded, the Judge shall award the Best of Breed to the best exhibit of that breed.
 - 22.1.3 In the event of both Challenge Certificates being withheld by a Judge, the Best of Breed and Reserve Best of Breed shall not be awarded unless the Judge considers that either or both of the winners of the Champions Class merit these awards.
- 22.2 Once the Best of Breed has been awarded, the remaining exhibits compete against the runner-up to the Best of Breed exhibit (i.e. the relevant Reserve Challenge Certificate winner or the runner-up in the relevant Champions Class) for Reserve Best of Breed. The Reserve Best of Breed shall be awarded to the dog placed second to the Best of Breed, which shall progress no further. For the avoidance of doubt, should the Best of Breed be awarded to the Challenge Certificate winner that is also the winner of the Champions Class, the Reserve Challenge Certificate winner as well as the runner-up in the Champions Class shall be entitled to challenge for the Reserve Best of Breed.
- 22.3 In the event of the Best of Breed or Reserve Best of Breed winners being entered in the Minor Puppy or Puppy classes, that exhibit shall automatically be awarded Best Puppy of Breed.
 - 22.3.1 On completion of Best of Breed judging, and provided that the Best of Breed and Reserve Best of Breed winners were not entered in the Minor Puppy or Puppy Classes, Best Puppy of Breed will be judged. The exhibits eligible to compete for Best Puppy of Breed shall be the winners of the Minor Puppy and Puppy Classes of either sex, provided they have not been beaten by another Puppy Class

winner for the challenge Certificate or Reserve Challenge Certificate. If the Judge is not of the opinion that the puppy selected is worthy of the award of Best Puppy of Breed, he may withhold it.

- 22.4 Once Best Puppy of Breed has been awarded, the remaining Best Class of Breed awards scheduled by the Club, excluding Baby Puppy and Neuter Dog, will be judged in the same order as the breed Classes.
- 22.5 On completion of the Best Class in Breed awards, the Baby Puppy Dog and Baby Puppy Bitch Classes, if scheduled, shall be judged, followed by Best Baby Puppy of Breed.
- 22.6 On completion of the Baby Puppy of Breed awards, the Neuter Dog Class, if scheduled, shall be judged.
- 22.7 If the Judge is of the opinion that none of the exhibits eligible for any Best Class in Breed award is worthy of the award, he may withhold it.
- 22.8 In addition to the Challenge Certificates and Reserve Challenge Certificates issued in terms of Regulation 21.4 of this Schedule, the following Breed Award Certificates shall be issued either in hard copy, or digitally and, if issued electronically, digitally system-signed and verifiable, shall be available to exhibitors within thirty (30) days of the date of such award being made:

Champions Class First Place
Best of Breed
Reserve Best of Breed
Best Junior of Breed
Best Puppy of Breed
Best Baby Puppy of Breed
Best Veteran of Breed
Best Neutered of Breed

- 22.9 By applying his signature to the various Certificates or, when these awards are electronically issued as digitally system-signed and verifiable Certificates, the Show Secretary assumes responsibility for the accuracy and validity of any certificates issued in confirmation of awards made in terms of these Regulations. The responsibility to rectify any errors which might occur on any of the Certificates and to issue corrected Certificates either in hard copy or digitally, shall rest with the Show Secretary.

23. ORDER OF MERIT ON DISQUALIFICATION OF PRIZE WINNER

- 23.1 Subject to the provisions of Regulation 23.3 hereof, in the event of a prize winner being disqualified in terms of these Regulations, the succeeding prizewinning dogs in consecutive order of merit shall be advanced to the next highest placing, which shall thereupon become the awards.
- 23.2 In the event of the winner being so disqualified, the winner of the Reserve Challenge Certificate shall be advanced and it shall be awarded the Challenge Certificate.
- 23.3 No prize winner exhibit which was not awarded the Reserve Challenge Certificate shall be awarded a Challenge Certificate or Reserve Challenge Certificate under this Regulation.

24. COMPETITION FOR GROUP WINNERS, BEST IN SHOW WINNERS AND BEST PUPPY IN SHOW WINNERS – BREED AWARDS AND CERTIFICATES

- 24.1 At every Championship Show where dogs of more than one Group are scheduled, dogs awarded Best of Breed and Best Puppy of Breed shall be eligible for free entry into their respective Group Challenges. The Group Challenges will be based upon the groupings of the breeds as shown in Regulation for Classification, Registration & Transfer of the Registered Ownership of Dogs (Schedule 02).
 - 24.1.1 The first four (4) exhibits in the Group and Puppy Group shall be placed 1 to 4 in order of merit (and may be announced in reverse order).
 - 24.1.2 The winners of the Group and Puppy Group shall be eligible for free entry into their respective Best in Show Challenges
 - 24.1.3 Clubs may also schedule Group and In Show challenges for any other breed classes offered at the show.
 - 24.1.4 The winners of Best of any such class in Breed shall be eligible for free entry into their respective Group Challenges and the winners of Best in these Group challenges shall be eligible for free entry into their respective Best in Show Challenges
 - 24.1.5 Details of the order of judging of the various Group Challenges and the order of judging of the various Best in Show Challenges on offer shall be published in the show schedule and in the catalogue.
- 24.2 At every Championship Show where dogs of more than one Group are scheduled, two (2) exhibits shall be placed in all In Show challenges. Whilst exhibits must be placed in order of merit, the results may be announced in reverse order.
 - 24.2.1 At every Championship Show where dogs of more than one breed, but confined to one Group only, are scheduled, Specialist Multi-breed Shows included, dogs awarded Best of Breed and Best Puppy of Breed shall be eligible for free entry into their respective Best in Show Challenges.

- 24.2.2 Such Clubs may also schedule In Show challenges for any other breed classes offered at the show.
- 24.2.3 The winners of Best of any such class in Breed shall be eligible for free entry into their respective Best in Show Challenges
- 24.2.4 At every Championship Show where dogs of more than one breed, but confined to one Group only, are scheduled, Specialist Multi-breed Shows excluded, the first four (4) exhibits in the Best in Show and Best Puppy in Show shall be placed 1 to 4 in order of merit (and may be announced in reverse order).
- 24.2.5 At every Specialist Multi-breed Championship Show where two or more breeds confined to a single Group is scheduled, once the Judge has made his choice for Best in Show, the remaining exhibit(s) shall await the recall of the runner-up to the Best in Show in the Breed Challenge, i.e. the Reserve Best of Breed exhibit, to challenge for Reserve Best in Show. All other best Class of Breed awards shall be made on an inter-breed basis.
- 24.2.6 The various Best in Show Challenges, whether at a Group, multiple Group or All-Breeds Championship Show, shall be judged by the same Judge.
- 24.2.7 Details of the order of judging of the various Best in Show Challenges on offer shall be published in the show schedule and in the catalogue.
- 24.3 At every Championship Show where dogs of one breed only are scheduled, the exhibits eligible to compete free of entry fees for Best in Show are Challenge Certificate winners and unbeaten prize winners in any restricted class as defined in Appendix 1 of this Schedule, and the exhibits eligible to compete free of entry fees for Best Puppy in Show are all the Minor Puppy and Puppy class winners.
- 24.3.1 At every Specialist Championship Show where two or more varieties of a Breed are scheduled, the Club shall be entitled to elect whether, for Reserve Best in Show, there would be a call-back of the runner-up to the dog awarded Best in Show (i.e. the Reserve Best of Breed in that variety), or whether Reserve Best in Show would be awarded the Best of Breed winner of the other variety/one of the other varieties. The procedure for rewarding Best in Show should be clearly stipulated in the Show Schedule.
- 24.4 In addition to the various Certificates issued in terms of Regulations 21.4 and 22.7 of this Schedule, the following Winners/Award Certificates shall be issued either in hard copy, or electronically, at all Championship Shows where applicable and where scheduled, signed by the Judge and Show Secretary or, when issued electronically, digitally system-signed and verifiable, and shall be available to Exhibitors within thirty (30) days of the date of such award been made:
- Best in Group
 - Best Puppy in Group
 - Best Junior in Group
 - Best Veteran in Group
 - Best Baby Puppy in Group
 - Best in Show
 - Reserve Best in Show
 - Best Puppy in Show
 - Best Junior in Show
 - Best Veteran in Show
 - Best Baby Puppy in Show
 - Best SA Bred in Show
 - Best Neutered Dog in Show
 - Best Namibian Bred in Show
- 24.5 By their signature thereto, however applied, or when issued electronically, digitally system-signed and verifiable, the Show Secretary assumes responsibility for the accuracy and validity of any Winners/Awards Certificates issued in confirmation of awards made in terms of these Regulations. The responsibility shall rest with the Show Secretary to rectify any errors which occur on any Award Certificates and to reissue corrected certificates either in hard copy or digitally.
- 24.6 If Award Certificates are to be issued electronically as contemplated in Regulation 24.5, it shall be so stated in the Show Schedule.
25. **CLASSIFICATION**
An Affiliated Club may make such classification and offer such prizes as it thinks fit, subject to the condition that:
- 25.1 no classification shall be contrary to those classifications set out in Appendix 1 hereof;
- 25.2 no classes or prizes shall be offered for progeny sired by a specified dog.
26. **AGE RESTRICTIONS**
No puppy under the age of four (4) months on the first day of the Show shall be eligible for entry.

27. **KENNEL UNION CONSTITUTION AND SHOW REGULATIONS**

A copy of the Kennel Union Constitution and Show Regulations currently in force shall be made available by the Show Committee and shall be accessible to any Exhibitor at a show.

28. **PUBLIC LIABILITY INSURANCE**

28.1 Every Club holding a Championship Show shall be protected by the Kennel Union Public Liability Insurance Policy throughout the duration of the Show and it shall be compulsory for every Affiliated Club to subscribe to such policy without the right to contract out there from.

28.2 Any Affiliated Club may insure itself and its members at its own cost against the risk of public liability for any hazard to obtain additional protection during a Show, provided that such additional protection does not invalidate such Club's compulsory participation in the Kennel Union Public Liability Policy.

29. **PRIZES**

29.1 Prize money donated by a commercial source or any other sponsor whatsoever for any one class, shall be unlimited. Prize money paid out to winners shall be paid at the sole risk of the club concerned. The Kennel Union of Southern Africa is not responsible for any unpaid prize money for any reason whatsoever.

29.2 All prize money shall be paid to the winners free of deduction, save and except for bank commission and charges, poundage on postal orders, and in any case where a prize winner is indebted to the Show holding Club.

29.3 Whenever an objection has been lodged to a prize winning dog, the prize money shall not be paid out until the objection has been finally determined and the Secretary has notified the Show holding Club.

30. **GRADING CERTIFICATES**

In those breeds where dogs are graded by an approved Judge, a KUSA Grading Certificate may be issued in addition to any Certificates awarded in terms of Regulation 21 of this Schedule.

31. **OBJECTION TO DOGS AND DISQUALIFICATIONS**

31.1 Any person except a person on whom *persona non grata* has been imposed by the Federal Council, or who is under a term of suspension or disqualification imposed by the Executive Committee may lodge an objection to a dog entered for, exhibited at or present and intended to be exhibited at a Show, subject to the limitation imposed by Sub-Regulation 31.3 hereof.

31.1.1 Any rectification of an award except as a result of a *bona fide* clerical error, cannot be raised later than twelve (12) months after the first day of the show.

31.2 Every objection lodged with the show holding Club under this Regulation shall be reduced to writing, delivered to the Show Secretary at the Show and shall be accompanied by a deposit in terms of Subscriptions & Fees (Schedule 07) in respect of each exhibit objected to, unless the objection is made by the Show Committee which shall not be required to lodge a deposit.

31.3 The grounds of objection made to a dog and immediate disqualification of such dog in terms of this Regulation shall be any one or more of the following:

31.3.1 that it has been improperly tampered with;

31.3.2 that it is blind;

31.3.3 that it is deaf;

31.3.4 that it is not entire, except for the Neuter Dog Class, it does not possess two testicles, apparently normal, which are both descended and can be felt in the scrotum;

31.3.5 that it is suffering from any form of contagious or infectious disease;

31.3.6 that it has been improperly prepared for exhibition in contravention of Regulation 38. Any contravention of this Regulation must be dealt with by the officiating Judge at his discretion.

31.3.7 that it has been entered in a manner not complying with the classification in the Show Schedule;

31.3.8 VOID

31.3.9 that it has been exhibited by a person disqualified or suspended by the Federal Council or the Executive Committee, or by a person on whom *persona non grata* has been imposed by the Federal Council.

31.3.10 that it has been registered in the name of and owned by a person disqualified or suspended by the Federal Council or the Executive Committee;

31.3.11 that it has been entered contrary to these Regulations;

31.3.12 that it has been exhibited contrary to these Regulations;

31.3.13 that it has been operated upon in contravention of these Regulations;

31.3.14 that it has been entered and/or exhibited at a Show when it is registered or recorded as owned by an officiating Judge within a period of four (4) months prior to the Show, when said officiating Judge is scheduled to judge any Class or Competition to which the dog may gain admission through its

entry, except in the case of a dog owned by the officiating Judge appointed in an emergency, in which case the disqualification of the dog will be automatic without any liability incurred by the emergency appointed Judge.

- 31.4 Upon receipt of a written objection and a deposit, the Show Secretary shall immediately notify the owner, exhibitor or handler in charge of the dog, who shall be obliged to take the dog, subject to objection, to a convenient place nominated by the Show Secretary for examination by a Veterinary Surgeon whenever such objection is based upon any of the grounds set out in Regulations 31.3.1 to 31.3.15. Following such examination, the Show Secretary shall obtain from the Veterinary Surgeon a written report on the dog examined. The Veterinary Report, together with the written objection and, in the case of an objection based upon any of the grounds set out in Regulations 31.3.6 to 31.3.8, the written objection and any supporting papers shall be investigated and considered by the Show Committee without delay.
- 31.5 The Show Committee shall make a finding on all the facts of such objection and in the event of a majority finding that the objection is upheld, the dog shall be disqualified with effect from the commencement of the Show. Notice of such finding shall be communicated without delay to the objector and the owner, exhibitor or handler in charge of the dog. The owner, exhibitor or handler of any dog so disqualified shall have the right to lodge an appeal in writing to the Executive Committee within fourteen (14) days, but such notice of appeal shall not operate as a bar on suspension of the Show Committee's decision to disqualify a dog.
- 31.6 In the event of a majority of the Show Committee rejecting the objection, notice of such finding shall be communicated without delay to the objector and the owner, exhibitor or handler in charge of the dog, which shall be permitted to compete as if no such objection had been lodged.
- 31.7 Within twenty-four (24) hours of the Show closing, the Show Secretary shall forward a report to the Secretary setting out:
- 31.7.1 the name and address of the objector;
 - 31.7.2 a copy of the objection;
 - 31.7.3 the name and address of the owner and, where relevant, the name and address of the exhibitor or handler in charge of the dog at the Show;
 - 31.7.4 the name and address of the Veterinary Surgeon who examined the dog, where applicable;
 - 31.7.5 a copy of the Veterinary Surgeon's report, where applicable;
 - 31.7.6 any other supporting papers or relevant evidence.
- 31.8 Upon receipt of the Show Secretary's report, the Secretary shall:
- 31.8.1 In the event of no notice of appeal received with the report, present the matter for consideration to the Executive Committee only after the lapsing of the 14 (fourteen) day period as referred to in Schedule 03 Regulation 31.5.
 - 31.8.2 In the event of receiving a notice of appeal in terms of Schedule 03 Regulation 31.5, the Secretary shall inform the Show Secretary of the Club thereof and request the Show Committee to provide a response thereto within 7 (seven) days and thereafter present the matter for consideration to the Executive Committee.
 - 31.8.3 The Executive Committee shall consider all the documentation as presented to them by the Secretary received in terms of Schedule 03 Regulation 31.8.1 or 38.1.2 and:
 - 31.8.3.1 either confirm, quash or vary the Show Committee's finding, subject to the limitation that the results of a Show following any disqualification imposed by the Show Committee shall not be amended in any way.
 - 31.8.3.2 The Executive Committee's decisions in this regard shall be final.
- 31.9 At the time of making its decision in terms of Sub-Regulation 31.8, the Executive Committee shall make an order relating to the deposit lodged by the objector in terms of Regulation 31.2. In the event of the objection being upheld, the Executive Committee shall order that the deposit be refunded to the objector by the Show Committee. In the event of the objection being rejected, the Executive Committee may order that the whole or any part of the deposit be awarded to the owner of the dog against which the objection was lodged and that any part not so awarded be refunded to the objector by the Show Committee.
- 31.10 In the absence of any objection being lodged by any person in terms of Regulations 31.1 and 31.2, the Show Committee shall nevertheless be empowered to act on its own initiative upon any of the grounds set out in Regulation 31.3, whereupon all the provisions of this Regulation shall apply *mutatis mutandis*.
- 31.11 Notwithstanding the provisions of this Regulation hereinbefore set forth, any person may make a complaint based on the grounds of objection set out in Sub-Regulation 31.3 within twenty-one (21) days after the closing of the Show, but in every such event a complaint shall be made and dealt with in accordance with the procedure set forth in the Disciplinary Rules (Schedule 01).
- 31.12 Notwithstanding the provisions of this Regulation hereinbefore set forth, in consequence of any decision made under this Regulation, the Executive Committee may instruct the Secretary to make a complaint under Rule 2 of the Disciplinary Rules (Schedule 01), where after it shall be dealt with in accordance with the procedure set forth in the Disciplinary Rules (Schedule 01).

32. DISQUALIFICATION AND FORFEITURE OF PRIZES

- 32.1 If any one of the grounds of objection set forth in Regulation 31.3 is proved against and in respect of any dog, its entry fees may be forfeited to the Show holding Club and it may be disqualified from competition and winning any award or prize by: -
- 32.1.1 the Show Committee acting on an objection lodged in terms of Regulation 31;
 - 32.1.2 the Show Committee acting on its own initiative in terms of Regulation 31;
 - 32.1.3 the Executive Committee acting in terms of Regulation 31.
- 32.2 Whenever a dog or dogs are promoted in order of merit, as provided by Regulation 23, in consequence of a disqualification, notice thereof shall be given to the owner or owners by the Secretary.
- 32.3 The Executive Committee shall be empowered to publish in the Official Kennel Union Journal full details of every dog disqualified, including the name and address of the owner, exhibitor or handler in charge of the dog, and the nature of the objection giving rise to disqualification. The Executive Committee shall have further power to provide full details of every such disqualification to Affiliated Clubs, National or International Governing Bodies in reciprocity with or recognised by the Kennel Union and such persons as it shall deem fit. The owner of the dog disqualified must return any prizes and certificates awarded to the Show Secretary within twenty (20) days after the appeal period contemplated in Regulation 31.5 has passed.

33. FINE AND PENALTIES

- 33.1 If a dog is entered in a class for which it is ineligible and it is not withdrawn from competition therein, or rectified by the Show Office before such class is judged, such dog shall be disqualified and the exhibitor may be fined at the discretion of the Executive Committee.
- 33.2 The Executive Committee shall have power to impose a fine upon any exhibitor who makes an error in his Show Entry Form or infringes any provision of these Regulations and withdraw any prizes awarded on the day.
- 33.3 In the event of any fine not being paid within the time stipulated by the Executive Committee, the exhibitor may, at the discretion of the Executive Committee, be dealt with as if a complaint brought under Kennel Union Disciplinary Rules, Rule 4 (Schedule 01), had been lodged against him and proved to the satisfaction of the Executive Committee.
- 33.4 The Executive Committee shall have the power to take such further remedial or punitive action as deemed appropriate to redress instances of discreditable conduct referred to it by the Secretary in terms of Regulation 37.4.1, which shall be limited to Letters of Demand, Letters of Warning, fines, or the imposition of restrictions on Clubs to accept Show Entries for the exhibition of certain dogs at Championship Shows, such restrictions only to be lifted by the Executive Committee once all the conditions of the imposed sanctions have been met.

34. JUDGES

- 34.1 The Executive Committee or the appropriate Standing Sub-Committee shall be empowered to approve the appointment of all Judges at all recognised Shows at which Kennel Union awards are offered for competition and no Judge shall officiate at any such Show unless he has been approved by the Executive Committee.
- 34.2 The Executive Committee shall maintain panels of Judges /Evaluators approved to award Challenge Certificates for Breed, Qualifying Certificates for Obedience Classes, Working Trials, Field Trials, Companion Events and such other Certificates which may be awarded in terms of any Schedule forming part of this Constitution.
- 34.3 Before any person is approved to award any Certificate or award, the Executive Committee shall have regard to his knowledge and experience as a breeder, exhibitor and Judge and may call for such information as may be required to assess such knowledge and experience. In every assessment made the Executive Committee shall take into consideration such evaluations as may have been submitted in terms of the relative Schedules to this Constitution.
- 34.4 Before approving a foreign Judge or a Judge from a body recognised in terms of Article 21.4 to officiate at a Championship Show, the Kennel Union Office shall be satisfied that such Judge is eligible to judge the Breeds contemplated to be judged at such Championship Show in accordance with the guidelines for the clearance of foreign Judges approved by the Federal Council from time to time.
- 34.5 All locally domiciled Judges shall be members in good standing of the Kennel Union and shall be over the age of eighteen (18) years at the time when formal studies or activities towards a judging qualification commence, and/or any judging is undertaken.

35. RING NUMBERS

- 35.1 Every exhibitor or handler shall wear a distinctive number, the digits of which shall be not less than 2.5 cm in height, to identify each dog exhibited in the Judging Ring. The dog's number shall be allocated and issued by the Show Secretary.

- 35.2 When in the Judging Ring, no exhibitor, handler or dog shall wear or exhibit any rosette, award, name, Kennel name or other device which may identify or advertise the dog or its kennel save and except winners of Best of Breed rosettes may wear these when in the ring for Group judging and winners for Best of Group rosettes may wear these, but not additional to Best of Breed rosettes, when in the ring for Best in Show judging. Such rosettes shall bear ONLY the nature of the award and the name of the Show holding Club and sponsor, if any.

36. FLOATING TROPHIES

- 36.1 The conditions under which Floating Trophies can be competed for shall be inserted in the Schedule or the Catalogue of every Show in which they are offered for competition and such conditions may not be amended in respect of that Show.
- 36.2 Whenever called upon to do so, the Committee of every Affiliated Club shall forward to the Secretary a list of all Floating Trophies owned by the Club, together with the conditions of competition therefor.

37. FRAUDULENT OR DISCREDITABLE CONDUCT

- 37.1 The Show Committee shall report, in writing, to the Secretary any case of alleged fraudulent or discreditable conduct, and any default or omission at or in connection with a Show which is brought to its notice. Every such report shall be submitted to the Secretary within seven (7) days of the Show, disclosing all information pertaining to the alleged discreditable conduct brought to the attention of the Show Committee and all documents placed in its possession. Additional documentation and information in support of the report may be submitted to the Secretary up to twenty-one (21) days after the Show.
- 37.2 Without limiting the extent and meaning thereof, fraudulent conduct shall include, *inter alia*, the exhibition of dogs under the name or registration number of another dog, and any arrangement proposed, suggested, offered or entered into with a Judge to influence or intended to influence his placing or awards.
- 37.3 Without limiting the extent and meaning thereof, discreditable conduct shall include *inter alia* wilfully, by word or letter, attempting to influence exhibitors to boycott a Show, wilfully speaking to or treating a Judge or any Show Official in a disrespectful or contemptuous manner, permitting his exhibit to be attracted from outside the Judging Ring in a manner and to an extent not contemplated in Regulation 16.4 hereof; failing to pay entry fees or other dues in respect of the Show; wilfully acting or behaving in opposition to these Regulations; making any false declaration upon his Show Entry Form; failing to comply with any request properly made by a Show Official; any act of cruelty to or neglect of a dog; any disorderly or unseemly conduct at or within the precincts of a Show; making insulting or disparaging remarks of and about any dog, Exhibitor, Handler, Show Official, Judge or KUSA Representative at a Show.

[Note: Fedco 06-2026 Item 12.2.2 directs the amendments to Regulation 37.3 to be effective from 01.11.2026.]

- 37.4 Upon receipt of every report made in terms of Sub-Regulation 37.1 hereof, the Secretary shall refer the report to the Sub-Committee of Inquiry, established in terms of Schedule 01, to assess the nature and severity of the alleged discreditable conduct and, based on such assessment, to either:
- 37.4.1 refer the report and submitted documentation back to the Secretary with a request to enter into correspondence with the offender to demand redress of the alleged discreditable conduct with the recommendation that, should the Secretary's efforts fail to remedy the situation, for the report and submitted documentation to be referred to the Executive Committee to take such remedial or punitive action as deemed appropriate under Regulation 7.6 to redress the alleged discreditable conduct; or
- 37.4.2 refer the report and submitted documentation to a Disciplinary Sub-committee to be considered as a complaint lodged in terms of Schedule 01 (Disciplinary Rules), after which all the provisions of Schedule 01 shall apply thereto, with the exception of the Complaint Deposit, which shall be waived. The Complaint Deposit shall also be waived if the alleged discreditable conduct reported under Regulation 37.1 is towards a person officiating in the capacity of a Judge, Ring Steward or Show Manager at a KUSA-licensed Championship Show.

38. PREPARATION OF DOGS FOR EXHIBITION

- 38.1 The owner, exhibitor and handler of any dog responsible for or aiding and abetting the exhibition of a dog in contravention of Sub-Regulations 38.3 and 38.4 shall *prima facie* be guilty of discreditable conduct and may be dealt with under Disciplinary Rule 2 (Schedule 01).
- 38.2 Any dog exhibited in contravention of Sub-Regulations 38.3, 38.4 and 38.5 shall be liable to disqualification under the provisions of Regulations 31 and 32 thereof.

- 38.3.1 No dyeing, colouring, tinting, darkening, bleaching or other matter shall be used to alter or improve the colour or markings of a dog. Dry white chalk or other dressing may be used for cleaning and grooming, provided it is removed before the dog enters the ring.
- 38.3.2 No operation or act shall be performed whether by cutting, piercing, breaking by force or otherwise which destroys the tissue of an ear or ears or alters the natural formation of a dog or any anatomic part thereof; save and except:
 - 38.3.2.1 the performance of operations certified by a Veterinary Surgeon to be necessary or desirable on the grounds of health and accepted by the Executive Committee;
 - 38.3.2.2 the removal of dewclaws of a dog of any breed;
 - 38.3.2.3 the shortening of tails as determined in individual Breed Standards,
 - 38.3.2.4 the spaying of bitches. The neutering of dogs, these male dogs may only be entered in the Neuter Dog Class.
- 38.4 No alteration shall be made to the setting of any dog's teeth, save and except the performance of a dental operation certified by a Veterinary Surgeon or Dental Practitioner to be necessary or desirable on the grounds of health and accepted by the Executive Committee.
- 38.5 No dog shall be exhibited:
 - 38.5.1 with any oil, viscous, greasy or sticky substance adhering to the coat;
 - 38.5.2 with any artificial preparation adhering to the coat save and except a reasonable amount of chalk or dressing still remaining in the coat after cleaning and grooming;
 - 38.5.3 with any part of its coat cut or clipped by means other than a stripping comb save and except:
 - 38.5.3.1 the hair in front of the ears and on the legs and feet of a Pomeranian may be cut;
 - 38.5.3.2 the rasping down of the underside of tails is permitted in such breeds as it is customary to do so;
 - 38.5.3.3 the cutting of hair between the toes of any breed is permitted;
 - 38.5.3.4 Poodles, Bedlington Terriers and Kerry Blue Terriers, which three breeds are exempted from the provision of Sub-Regulation 38.5.3.
- 38.6 Nothing may be done to a dog which is calculated to deceive.

39. **OBEDIENCE CLASSES, WORKING TRIALS AND FIELD TRIALS**

Obedience Classes, Working Trials and Field Trials or other licensed event may be held at or in conjunction with any Championship Show, subject to the conduct thereof being in accordance with Kennel Union Regulations for such class, trial or event.

40. **CHILDREN'S HANDLER CLASS**

The changing of dogs between handlers is not permitted in this class.

41. **POWERS OF CLUB SHOW COMMITTEES**

Subject to the provisions of Regulations for Championship Shows set forth in Schedule 03, the Show Committee of an Affiliated Club shall be empowered to decide all questions of fact and deal with all disputes and objections arising out of or in connection with any Championship Show or other Show held at or in conjunction with and under the licence of such Championship Show held by such Club.

42. **CHAMPION DOGS**

Upon written application being made by a member on an official Kennel Union form, accompanied by the fee prescribed in terms of Schedule 07.

42.1 **Breed**

- 42.1.1 The Federal Council may award the title of breed Champion to any dog on the full Breed Register of the Kennel Union or any National Canine Organisation recognised by KUSA which has won, under different judges, a sufficient number of Challenge Certificates, the points of which amount to five(5) or more in aggregate provided that:
 - 42.1.1.1 Void
 - 42.1.1.2 at least one (1) point was gained after the dog was eighteen (18) months of age,
 - 42.1.1.3 the balance of the points was awarded after the dog was nine (9) months of age,
 - 42.1.1.4 the above condition shall apply to all Breeds with the exception of those Breeds for which special additional qualifications are required in respect of working tests, special judging, age limitation and any other qualifications agreed by the Executive Committee and more specifically detailed at Appendix I to this schedule. The details of Appendix I may from time to time be added to, suspended, revoked or amended by the Federal Council.
- 42.1.2 The Federal Council may award the title of breed Grand Champion to any dog on the full Breed Register of the Kennel Union or any National Canine Organisation recognised by KUSA which has won, a total of at least fifty (50) points as per Appendix 2, provided that:
 - 42.1.2.1 the dog is a KUSA Breed Champion of record.

- 42.1.2.2 not more than fifteen (15) of the minimum fifty (50) points were awarded by one (1) Judge,
- 42.1.2.3 points were gained in at least three (3) geographical provinces of South Africa or two (2) geographical provinces of South Africa plus Namibia.
- 42.1.2.4 only awards gained after 1 January 2012 shall count for points towards this title.
- 42.1.2.5 a maximum of forty (40) points won before 1 February 2017 shall count towards the title.
- 42.1.3 The Federal Council may award the title of breed Supreme Champion to any dog on the full Breed Register of the Kennel Union or any National Canine Organisation recognised by KUSA which has won, a total of at least one hundred and fifty (150) points as per Appendix 2, provided that:
 - 42.1.3.1 the dog is a KUSA Breed Grand Champion of record
 - 42.1.3.2 the dog has won at least one (1) Best in Show award at an All-breeds Championship Show.
 - 42.1.3.3 the dog has earned a Bronze Canine Good Citizen Certificate
 - 42.1.3.4 the dog has a DNA profile
 - 42.1.3.5 at least twenty (20) of the total points earned are Bonus Points as defined in Appendix 2
 - 42.1.3.6 not more than fifteen (15) of the minimum one hundred and fifty (150) points were awarded by one (1) judge
 - 42.1.3.7 points were gained in at least four (4) geographical provinces of South Africa or three (3) geographical provinces of South Africa plus Namibia
 - 42.1.3.8 only awards and qualifications gained after 1 January 2017 shall count towards this title.
- 42.1.4 The Federal Council or Executive Committee shall issue a Champion or Grand Champion Certificate, as the case may be, to the owner of every dog qualifying for each such award under the provisions of Schedule 03 Regulation 42 and any relevant Schedule of Regulations forming part of the KUSA Constitution.
- 42.1.5 Any dog which has achieved any type of Championship Status as described in this Regulation 42, or under any Schedule forming part of this Constitution, shall not be described as such until the Federal Council or Executive Committee has confirmed the appropriate award and the relevant Championship Certificate has been issued, notice of which shall thereafter be published in the official Kennel Union Journal.
- 42.1.6 The Federal Council may award the title of Junior Merit in breed to any dog on the full Breed Register of the Kennel Union or any National Canine Organisation recognised by KUSA which has won a minimum of eight (8) Best Puppy in breed and/or Best Junior in breed awards, as well as at least one Best Puppy in Group or Best Junior in Group award at Championship Shows licensed by the Kennel Union.
- 42.1.7. Sire of Merit (SOM) and Dam of Merit (DOM) Titles
 - 42.1.7.1. The Federal Council may award the title of "Sire of Merit (SOM)" to any dog registered on the Primary Breed Register of the Kennel Union, or registered by any National Canine Organisation recognised by KUSA, which has produced no fewer than ten (10) Breed Champion offspring registered with KUSA or with any National Canine Organisation recognised by KUSA.
 - 42.1.7.2. The Federal Council may award the title of "Dam of Merit (DOM)" to any dog registered on the Primary Breed Register of the Kennel Union, or registered by any National Canine Organisation recognised by KUSA, which has produced no fewer than five (5) Breed Champion offspring registered with KUSA or with any National Canine Organisation recognised by KUSA.
 - 42.1.7.3. At least three (3) of the Breed Champion titles, gained by the offspring (CH, GR.CH, SP.CH, INT.CH (C.I.B.), FCI A2O CH), must have been awarded after the implementation date.
 - 42.1.7.4. The Federal Council or Executive Committee shall issue a "Sire of Merit (SOM)" or "Dam of Merit (DOM)" Award Certificate, as the case may be, to the Registered Owner(s) of every dog qualifying for such an Award under the provisions of Schedule 03 Regulation 42 and any relevant Schedule of Regulations forming part of the KUSA Constitution.

42.2 Obedience

The Federal Council or Executive Committee shall award:

- 42.2.1 the title of Obedience Champion to any dog which has won three (3) Kennel Union Obedience Certificates under three (3) different Judges.
- 42.2.2 the title of Grand Champion – Obedience and a KUSA certificate to any dog which has been awarded twenty-five (25) Obedience Qualifying Certificates, provided that no more than three (3) of such Obedience Qualifying Certificates shall have been awarded by any one (1) judge and not more than twenty (20) of such certificates were gained in any one (1) province, with the balance of five (5) certificates having been gained in at least two (2) other provinces. Twelve (12) Obedience Qualifying Certificates awarded to a dog prior to 1 January 2005 shall count towards this award.

42.3 Working Trials

The Federal Council or Executive Committee shall award:

- 42.3.1 **Tracker Dog Champion**

- 42.3.1.1 The title Tracker Dog Champion and a KUSA certificate to any dog that has been awarded three (3) qualifying certificates, provided at least one (1) graded excellent, each by a different Judge in the grade Tracker Dog III.
- 42.3.1.2 The title Grand Champion Tracker Dog and a KUSA certificate to any dog that has been awarded fifteen (15) Tracker Dog qualifying certificates, provided that no more than four (4) of such qualifying certificates shall have been awarded by any one judge. Tracker Dog Qualifying certificates awarded to a dog prior to 1.1.2007 shall count towards this award.
- 42.3.2 **Police Dog Champion**
The Federal Council or Executive Committee shall award:
 - 42.3.2.1 The title Police Dog Champion and a KUSA certificate to any dog that has been awarded three (3) qualifying certificates in the grade Police Dog.
 - 42.3.2.2 The title Grand Champion Police Dog and a KUSA certificate to any dog that has been awarded nine (9) Police Dog qualifying certificates, provided that no more than three (3) of such qualifying certificates shall have been awarded by any one judge. Police Dog Qualifying certificates awarded to a dog prior to 1.1.2007 shall count towards this award.
- 42.3.3 **Working Dog Champion**
The Federal Council or Executive Committee shall award:
 - 42.3.3.1 The title Working Dog Champion and a KUSA Certificate to a dog that has been awarded both of the following titles: Tracker Dog Champion and Police Dog Champion.
 - 42.3.3.2 The title Grand Champion Working Dog and a KUSA certificate to any dog that has been awarded both of the following titles: Grand Champion Tracker Dog and Grand Champion Police Dog.
- 42.4 **IGP (SA) Champion**
The Federal Council or Executive Committee shall award:
The title IGP (SA) Champion may be awarded to a dog that has qualified in FCI-IGP 3 under at least 2 different licensed judges, at least three times with average mark of 250/300, not less than 80% in tracking and obedience and 90% for defence work.
- 42.5 **TT (SA) Champion**
The Federal Council or Executive Committee shall award:
The title TT (SA) Champion to a dog that has been awarded three (3) Qualifications in the Grade TT5, one of which must be at Championship Show by at least two (2) different judges, with the grading 'very good'.
- 42.6 **Working Utility Dog (WUD) Champion**
The Federal Council or Executive Committee shall award:
 - 42.6.1 The title of Working Utility Dog Champion shall be awarded to any dog that has been awarded five (5) qualifying certificates at Championship Shows, provided that no more than two (2) such qualifying certificates are signed by any one Judge and at least three (3) are graded Excellent.
 - 42.6.2 The title of Working Utility Dog Grand Champion shall be awarded to a dog that has been awarded Twenty (20) Working Utility Dog qualifying certificates, provided that no more than four (4) such qualifying certificates are signed by any one Judge. No dog may become a Grand Champion unless it has received the title of Working Utility Dog Champion.
- 42.7 **Field Trial Champion**
The Federal Council or Executive Committee shall award the title of Field Trial Champion to any dog which qualified therefor in the manner following:
 - 42.7.1 Pointers and Setters
The winner of a Pointer and Setter Championship Stake.
 - 42.7.2 Retrievers
The winner of the Retriever Championship Stake; or
A dog which wins two (2) first prizes at two (2) Field Trials in Open Stakes for Retrievers.
 - 42.7.3 Spaniels (Gundog Group)
The winner of the Spaniel Championship Stake.
A dog which wins two (2) first prizes at two (2) Field Trials in Open Stakes for Spaniels.
 - 42.7.4 Breeds which Hunt, Point and Retrieve
The winner of the Championship Stake for dogs which Hunt, Point and Retrieve; or a dog which wins two (2) first prizes at two (2) Field Trials in Open Stakes for all breeds which Hunt, Point and Retrieve.
- 42.8 **Carting Champion**
 - 42.8.1 The title of Carting Champion to any dog which has been awarded three (3) KUSA Carting Qualifying Certificates under three (3) different Judges.
 - 42.8.2 the title of Grand Champion – Carting and a KUSA certificate to any dog which has been awarded twenty-five (25) Carting Qualifying Certificates, provided that no more than four (4) of such Carting Qualifying Certificates shall have been awarded by any one (1) Judge and not more than twenty-one (21) of such Qualifying Certificates were gained in any one (1) province, with the balance of four (4) Qualifying Certificates having been gained in at least one (1) other province. Twelve (12) Carting

Qualifying Certificates awarded to a dog prior to 1 January 2006 shall count towards this award.

42.9 Dog Jumping Champion

The Federal Council or Executive Committee shall award:

- 42.9.1 The title of Dog Jumping Champion to any dog which has been awarded three (3) Dog Jumping Qualifying Certificates, each by a different Judge.
- 42.9.2 The title of Grand Champion and a KUSA Certificate to any dog which has been awarded fifteen (15) Dog Jumping Qualifying Certificates.

42.10 Agility Contact and Non-Contact Champion

The Federal Council or Executive Committee Shall Award:

- 42.10.1 The title of Agility Contact Champion to any dog awarded three (3) Agility Contact Qualifying Certificates Championship Shows, each by a different Judge.
- 42.10.2 The title of Agility Non-Contact Champion to any dog awarded three (3) Agility Non-Contact Qualifying Certificates at Championship Shows each by a different Judge.
- 42.10.3 The title of Grand Champion Agility Contact and a KUSA Certificate, to any dog awarded fifteen (15) Qualifying Certificates in Agility Contact.
- 42.10.4 The title of Grand Champion Agility Non-Contact and a KUSA Certificate, to any dog awarded fifteen (15) Qualifying Certificates in Agility Non-Contact.

42.11 Flyball Champion

- 42.11.1 The title of Flyball Champion shall be awarded to any dog which has gained seven hundred (700) points or more, in any combination at Championship or Non-Championship Shows.
- 42.11.2 The title of Th One and Only – Flyball shall be awarded to any dog which has gained fifteen hundred (1500) points or more, in any combination, at Championship or Non-Championship Shows
- 42.11.3 The title of Grand Champion – Flyball and a KUSA Certificate shall be awarded to any dog which has earned two thousand (2000) points or more, in any combination, at Championship or Non-Championship Shows.

42.12 Rescue Dog Champion

The Federal Council or Executive Committee shall award:

The title of Rescue Dog Trial Champion and a KUSA Certificate to any dog that has achieved qualifications in all five (5) grades by at least two (2) different Judges, one of which must be at a Championship Show with a minimum grading of "Very Good".

42.13 Dog Dancing (Heelwork to Music & Musical Free Style) Champion

The Federal Council or the Executive Committee shall award:

- 42.13.1 The title of Musical Freestyle/Heelwork to Music Champion and a KUSA Certificate to any dog that has achieved Advanced Level, and has been awarded three (3) Qualifying Certificates under three (3) different Judges in any one of the following categories:
Singles, Pairs, Brace, Group, Veteran, Handy Dandy
All three (3) Qualifying Certificates must be earned, and Advanced Level achieved, in the same category and the category will be stated in brackets after the title of Dog Dancing Champion.
- 42.13.2 The title of Musical Freestyle/Heelwork to Music Grand Champion and a KUSA Certificate to any dog that has achieved Advanced Level and has been awarded twelve (12) Qualifying Certificates, with no more than four (4) awarded by one Judge in any one of the following categories:
Singles, Pairs, Brace, Group, Veterans, Handy Dandy.
All twelve (12) Qualifying Certificates must be earned at Advanced Level and achieved in the same category and the category will be stated in brackets after the title of Musical Freestyle/Heelwork to Music Grand Champion.
- 42.13.3 The title of Musical Freestyle/Heelwork to Music Supreme Champion and a KUSA Certificate to any dog that has achieved Advanced Level and has been awarded ten (10) Qualifying Certificates with minimum qualifying scores as specified in Schedule 05S Regulation 7.2.3/Schedule 05R Regulation 7.2.3, with no more than four (4) awarded by one Judge in any one of the following categories:
Singles, Pairs, Brace, Group, Veterans, Handy Dandy.
All ten (10) Qualifying Certificates must be earned at Advanced Level and achieved in the same category and the category will be stated in brackets after the title of Musical Freestyle/Heelwork to Music Supreme Champion.

42.14 Rally Classes Champion

The Federal Council or the Executive Committee shall award:

- 42.14.1 The title of Rally Champion and a KUSA Certificate to any dog that has achieved Master Class and has attained 95% or higher at three (3) Championship Shows under three (3) different judges.
- 42.14.2 The title of Rally Grand Champion and a KUSA Certificate to any dog that has achieved Grand Master Class and has been awarded fifteen (15) Qualifying Certificates at Championship Shows, evenly

issued under a minimum of three (3) different Judges. The three (3) Master Class Qualifying Certificates shall count towards this achievement.

42.15 Trick Dog Champion

The Federal Council or the Executive Committee shall award:

42.15.1 The title of Trick Dog Champion and a KUSA Certificate to any dog that has achieved a passing evaluation. The performance must be evaluated by two (2) Evaluators.

42.16 Hoopers Champion

The Federal Council or Executive Committee Shall award:

42.16.1 The title of Hoopers Champion to any dog awarded three (3) Hoopers Qualifying Certificates at Championship Shows, under any two (2) different Judges.

42.16.2 The title of Hoopers Grand Champion to any dog awarded ten (10) Hoopers Qualifying Certificates at Championship Shows, under any three (3) different Judges providing at least one is domiciled outside the dog's normal area of competition.

42.17 Additional Qualifications for Championship Status

The Breeds concerned to be published in the official Kennel Union Journal, from time to time, subject to a resolution of the Executive Committee and the additional qualifications agreed by a Breed Council, will become effective under the provisions of Article 40 in respect of amendments to the Articles of the Constitution.

42.17.1 German Shepherd Dogs

42.17.1.1 Only one (1) Challenge Certificate gained before the age of eighteen (18) months to count and the remaining points to be gained after the age of eighteen (18) months.

42.17.1.2 Achieved a grading of "V" (excellent) awarded at a KUSA Licensed Breed Show"

42.17.1.3 Applicant is able to produce acceptable documentation, including evidence of positive identification, attesting that the dog has been x-rayed for Hip Dysplasia at the minimum age of 12 months and the hips were found to be within the range of HD A1 to C2.

42.17.2 Rottweilers

42.17.2.1 Only one (1) Challenge Certificate gained before the age of eighteen (18) months to count and the remaining points to be gained after the age of eighteen (18) months.

42.17.2.2 Achieved at least two (2) gradings of "V" (excellent) from a Specialist Rottweiler Judge. The V gradings must be obtained by two (2) different Specialist Rottweiler judges. At least one (1) V grading should be obtained after the age of twenty-four (24) months.

42.17.2.3 Applicant is able to produce acceptable documentation, including evidence of positive identification, attesting that the dog has been x-rayed for Hip Dysplasia and Elbow Dysplasia at the minimum age of eighteen (18) months and the hips were found to be within the range of HD A1 to C2. There are currently no restrictions on the elbow scores.

42.17.2.4 The dog has been assessed by a qualified Breed Surveyor. (Note - the Breed Assessment does not include a fighting spirit and courage test).

42.17.3 Boerboel

42.17.3.1 In addition to the requirements as laid down in Regulation 42.1.1 to 42.1.3 (Champion dogs, Breed) an exhibit must have successfully completed a Breed & Character (Temperament) Assessment by a qualified Assessor with an "Excellent 85%+ rating.

42.18 Multiple Champion (M.CH)

The title M.CH may be recorded on the Certificate of Registration as a Prefix to the registered name of a dog that has been awarded the title of Champion in more than two (2) foreign countries.

43. BREEDERS' CERTIFICATE

Upon written application being made on an official Kennel Union form, accompanied by the prescribed fee, the Executive Committee shall issue a Breeders' Certificate to the breeder of every dog awarded its title of Champion, Grand Champion and Supreme Champion, provided such dog is registered in the Kennel Union Primary Breed Register.

44. CANCELLATION/POSTPONEMENT OF SHOWS AND REFUND OF SHOW ENTRY FEES

44.1 The Show Committee shall be entitled to cancel or postpone a Show on the day, either before it opens or before its completion, due to extreme weather conditions (e.g. torrential rain, thunder, lightning, extreme heat), inaccessibility of the grounds, adverse conditions on the grounds, non-functional facilities, riots, civil disturbances, fire, or any other reason deemed to be threatening to the safety and wellbeing of Exhibitors and their dogs. Should a Show be cancelled for the year as a result of any of the above or like reasons, show-holding Clubs shall be entitled to retain Show Entry Fees. Should the Show be postponed to a later date in the same year, the retained Show Entry Fees shall be offset against the Show Entry Fees due and payable for the Show to be held on the new date in the same year. Retained Show Entry Fees shall not be offset against Show Entry Fees payable for a Show in a future year.

44.2 The Show Committee shall be entitled to cancel or postpone a Show in advance of the Show taking place for any cause other than force majeure, such as strife within the Committee, cancellations of Judges, unavailability of the

venue, etc. Exhibitors who have already submitted their Show Entry Forms and Show Entry Fees for the Show, shall be informed of the cancellation/postponement without delay and be advised of the expeditious procedure for the refund of Show Entry Fees. In the case of cancellation of the Show for the year in question, Exhibitors shall be entitled to a full refund of Show Entry Fees within twenty-one (21) days of the notice of cancellation and, in the case of postponement of the Show to a later date in the same year, shall have the choice of having their Show Entry Fees retained by the Club to be offset against the Show Entry Fees due and payable for the Show to be held on a new date in the same year. Show Entry Fees shall not be retained by the Club to be offset against Show Entry Fees payable for a Show in a future year.

- 44.3 The Show Committee shall be entitled to cancel or postpone a Show in advance of the Show taking place as a result of a prior and/or prevailing force majeure event, including, natural disasters and Acts of God such as earthquakes, volcanic eruptions, tornados and floods, but also catastrophic events which pose a threat to life such as acts of terrorism and strikes, as well as acts that pose a threat to health such as toxic emissions, pestilence and biohazards, whether under a declared national State of Emergency or national State of Disaster, or not. If a Show is so cancelled or postponed, Show Entry Fees shall, at the choice of and as directed by the Exhibitor, be partially refunded, or retained in full by the Club to be offset against the Show Entry Fees of a future Show in the same year, or as a donation. Any refund to Exhibitors shall be net of the Club's proportionately calculated reasonably incurred expenses up to the date of cancellation or postponement of the Show, whether disbursed, or pending disbursement, such expenses to be calculated and determined by the show-holding Club at its sole discretion. Show Entry Fees shall not be retained to be offset against Show Entry Fees payable for a Show in a future year.
- 44.4 In the event of a Show being cancelled or postponed as a result of events contemplated in Sub-Regulations 44.1 to 44.3 above, the Club shall immediately inform the KUSA Office, contracted Judges and Exhibitors of such cancellation or postponement, and advise Exhibitors of the position regarding Show Entry Fees, i.e. whether they will be retained, partially refunded, or refunded, depending on the circumstances, as provided in Sub-Regulations 44.1 to 44.2 above.
- 44.5 Once the KUSA Office has been informed of the cancellation or postponement of a Show, the previously issued Show Licence shall either be cancelled, or be replaced by a new Licence for the Show to be held on a later date within six (6) months of the original Show date. The Executive Committee shall grant special dispensation to Clubs applying for a postponement of the Show in order to sanction their compliance with Sub-Regulations 6.1, 12.2 and 34.1, as well as with Regulation 20, hereof. In the case of the cancellation of a Show, the Show Licence Fee paid shall be non-refundable, whereas the replacement of a Show Licence, in the case of postponement, shall be free of charge.
- 44.6 The provisions of Sub-Regulation 1.2.3.3 shall not apply to Clubs cancelling a Show in terms of Sub-Regulations 41 to 43 hereof.

APPENDIX 1
DEFINITION OF BREED CLASSES AND ORDER OF BREED JUDGING

DEFINITION OF BREED CLASSES

It is compulsory for every Championship Show-holding Club holding Breed Classes to include the following Classes in the Show Schedule:

MINOR PUPPY (MP):	For dogs of six (6) and under nine (9) months of age on the first day of the Show.
PUPPY (PU):	For dogs of nine (9) and under twelve (12) months of age on the first day of the Show.
JUNIOR (JU):	For dogs of twelve (12) and under eighteen (18) months of age on the first day of the Show.
GRADUATE (GR):	For dogs of eighteen (18) and under twenty-four (24) months of age on the first day of the Show.
OPEN (OP):	For dogs of any Breed therein provided for.

The following Classes are optional and the Show Schedule should reflect the Club's choice of additional Breed Classes and/or Challenge Classes as required.

CHAMPIONS (CH):	For dogs awarded the title of Champion. If a dog is entered in this class only it may not compete for the award of a Challenge Certificate or Reserve Challenge Certificate.
MAIDEN (MA):	For dogs that have not won a prize at any Championship Show.
NOVICE (NV):	For dogs that have not won a first prize at any Championship Show.
LOCAL (LO):	For dogs domiciled within a radius of 160 kilometres of the Show.
SOUTH AFRICAN BRED (SA):	For dogs born in Southern Africa, south of the Limpopo River.
NAMIBIAN BRED (NA):	For dogs born in Namibia.
VISITORS (VI):	For dogs domiciled beyond a radius of 160 kilometres of the Show.
MEMBERS (ME):	For dogs where the exhibitor is a member of the Show-holding Club.
VETERANS (VE):	For dogs of any age specified in the Show Schedule but not less than seven (7) years of age on the first day of the Show.
BREEDERS (BR):	For dogs where the exhibitor is the Breeder. The Breeder of any dog is the owner of the dam at the time of whelping.
IMPORTED (IM):	For dogs not born in Southern Africa and imported therein from any country outside the jurisdiction of the Kennel Union of Southern Africa.
BRACE (BA):	For two (2) exhibits (either sex or mixed) of one (1) Breed belonging to the same exhibitor, each exhibit having been entered in a Breed Class other than Brace or Team.
TEAM (TE):	For three (3) or more exhibits (either sex or mixed) of one (1) Breed belonging to the same exhibitor, each separate exhibit having been entered in a Breed Class other than Brace or Team.
PROGENY (PR):	Not less than three (3) dogs each to have been exhibited in a Breed Class, together with Sire or Dam which need NOT have been exhibited in a BREED Class.
WORKING DOG CLASS (WD):	For dogs with any of the following minimum qualifications: Class "A" in Obedience, CD, FCI-IGP 1 in Working Trials, BWT or TT2/TT2.
NEUTER DOG (ND)	For dogs of any age that have been castrated for any reason whatsoever (not eligible for CC or BOB)
BABY PUPPY CLASS (BP)	For dogs of four (4) and under six (6) months of age on the first day of the show (Not eligible for CC or BOB. With separate classes for dogs and bitches)

For the purpose of this Appendix the term "Exhibitor" means the person who has, in terms of the Constitution, entered the dog for the competition.

The Champions Class is one in which the prize-winner shall be eligible for the award Best of Breed but shall not be eligible for the award of a Challenge Certificate or Reserve Challenge Certificate unless such prize-winner is also a prize-winner of any other class.

A Restricted Class is a class for which the entry is restricted to dogs which have accumulated sufficient Challenge Certificate points towards the title of Breed Champion and such title has been awarded by the Kennel Union.

CHILDREN'S HANDLER CLASS (CHC): (Schedule 05K)	For persons eight (8), but under twelve (12) years of age. When the person turns eleven (11), the person may elect to remain in the Child Handler Class until the day before they turn twelve (12) or elect to move to the Junior Handler Class. Once moved, he may not return to the Child Handler Class.
JUNIOR HANDLER CLASS (JHC): (Schedule 05K)	For persons of eleven (11), but under eighteen (18) years of age.
ADULT HANDLER CLASS (AHC): (Schedule 05K)	For persons over eighteen years of age.

When judging these Classes, the Judge shall only consider the ability of the handler to control, set up and gait the exhibit, together with the dress and ring demeanour of the handler. Only normal ring movements are allowed. The quality of the dog will NOT be taken into consideration by the judge.

ORDER OF BREED JUDGING

1. Breeds shall, by default, be judged in the order as listed in Schedule 02 Appendix "A1". In the case of:
 - 1.1 A full Group allocated to a single Judge, the breeds will be judged in the order they are listed in Schedule 02 Appendix "A1", unless varied by the Club with good cause and the revised judging order is published in the Official accepted Show Schedule;
 - 1.2 an alphabetically split part Group, e.g. A – M and N – Z, allocated to two different Judges, the breeds will be judged in the split order they are listed in Schedule 02 Appendix "A1", unless varied by the Club with good cause and the revised judging order is published in the Official accepted Show Schedule;
 - 1.3 a randomly split part Group, whether based on numerical strength, size, function or propensity, allocated to two or more different Judges, the order of judging shall be as published in the Show Schedule; and
 - 1.4 randomly selected breeds, allocated to a Judge in addition to a full or part Group, the order of judging shall be as published in the Show Schedule, e.g. [Breed(s) Name(s)] after/before the [Group Name] Group.
2. Should the change in judging order in Regulations 1.1 and 1.2 above be necessitated or prompted by the accommodation of the judging order or starting times of Specialist Clubs or Group Clubs holding their Shows on the same day and at the same venue, the host Club shall ensure that all arrangements with Specialist Clubs or Group Clubs pertaining to the order of judging, starting times, and any foreseeable possible suspensions of judging due to clashes, are properly formalised in Letters of Agreement between the host Club and the Clubs holding their Shows in tandem with the Show of the host Club, which shall be submitted together with the draft Show Schedule to the KUSA office for audit and acceptance.
3. In breeds for which KUSA has adopted the FCI Breed Standard, in which more than one variety of the breed is identified for the awards of FCI-C.A.C. or FCI-C.A.C.I.B., such varieties will also be eligible for separate KUSA CCs. In the case of breeds for which KUSA has adopted the Breed Standards of The Royal Kennel Club (UK), KUSA CCs and FCI-C.A.C.s will be awarded separately to the varieties identified in the adopted KUSA Breed Standard but, at FCI International Shows, the varieties identified in the FCI Breed Standards of the same breeds will be eligible for separate FCI-C.A.C.I.B.s.
