NOTES:

- All Licence Applications must be accompanied by a Budget indicating estimated income and expenses.
- The budget is to be approved by the Fedco KUSA Classic Committee (FKCC) prior to the issue of the Licence.
- Shows must be self-funded from income derived from Entry Fees, Sponsorship or Fundraising.
- Contact the Office regarding Rosettes and medals.
- Exhibitor Entry Fees must be paid into the KUSA Classic Bank Account (excl Field Trials):

- After the Show a "Return of Show Entry" Form must be completed and submitted to the KUSA Shows' Department (showadmin@kusa.co.za) - One form per individual Show
- For KUSA National Events the number of entries must be declared, whereas the amount due will reflect R0.
- Entry-per-dog Levies payable to KUSA will be deducted from the Entry Fees paid into the KUSA Classic Bank Account.
- Only expenses incurred that were pre-approved by the FKCC may be lodged for reimbursement.
- Details of the Claims Procedure will be advised on confirmation of your Budget.
