GOVERNING THE SUPREME BULL TERRIER OF SOUTHERN AFRICA AND BULL

TERRIER MAJOR TROPHY SHOW

("the MTS")

AND RELATED MATTERS

CHAPTER 1

1 LICENSING, YEAR NAME AND APPLICABILITY OF CERTAIN REGULATIONS

- 1.1 The MTS is held under a Kennel Union of Southern Africa ("KUSA") issued Special Event License ("SEL").
- 1.2 The MTS is held annually in the year following that in which it is named, for example, the 2021 MTS is held in 2022.
- 1.3 These Regulations relating to licensing and all other matters relating to shows as set out in Schedule 3 – Regulations for Championship Shows (Breed), Schedule 4 – Regulations of Non-Championship Shows (Breed) and Schedule 5E of the Constitution of the KUSA shall apply to the MTS, as far as they could be relevant to the MTS and do not conflict with the specific terms of this Schedule.
- 1.4 The MTS is to be held annually on the first weekend of February, or such alternative date as decided upon by the Major Trophy Show Organising Committee ("MTSOC") and approved by KUSA.

2 SCOPE OF THE LICENCE

The South African Bull Terrier Club ("the SABTC") being a KUSA affiliated club who under the KUSA Constitution is licensed to hold Championship and Non-Championship Shows, may in addition annually and exclusively hold the MTS.

3 EXHIBITING AND COMPETING IN THE MTS

Any Bull Terrier registered with KUSA in its Breed Register for Bull Terriers and which has:

- 3.1 qualified in terms of these Regulations; and
- 3.2 is not disqualified, suspended, or temporarily excluded from competition by the KUSA, at the commencement of the MTS; and
- 3.3 whose owner/s and/or handler is in good standing with KUSA; may be exhibited and compete in the MTS

4 HOST CLUB

SABTC is the exclusive host club of the MTS.

5 ENTRY QUALIFICATION

- 5.1 The MTS is open to all Bull Terriers that have been awarded, at a KUSA licensed Championship Show, any time during the 12-month period preceding the MTS, reckoned from 1 January to 31 December:

- 5.1.1 a Best of Breed, Reserve Best of Breed, or a Challenge Certificate; or
- 5.1.2 a Reserve Challenge Certificate awarded by a SABTC Recognition of Merit ("ROM") Judge;

- 5.2 Every previous winner of a Dog or Bitch of the Year awards at any previous MTS, automatically qualifies to enter the MTS.

- 5.3 To enter the MTS, exhibitors are required to complete and submit by e-mail to the MTS Show Secretary:

- 5.3.1 an entry form as prescribed by the SABTC for every exhibit entered; and
- 5.3.2 a copy of a voucher proving payment of the full entry fee as indicated on the MTS Show Schedule; and
- 5.3.3 a copy of the exhibit's current and valid KUSA Certificate of Registration and Certified Pedigree; and
- 5.3.4 a digital high-resolution colour photograph of the exhibit entered; and
- 5.3.5 copies of the Certificates referred to in Regulation 5.1.1 and 5.1.2 of these Regulations;

to the secretary of the MTSOC, by the closing date as indicated on the MTS Show Schedule.

- 5.4 If and when the MTS is sponsored by one or more event and prize sponsors, owners and exhibitors may not use their dogs, or awards gained at the MTS for the purpose of advertising any product or service without the prior written permission of SABTC Management Committee.

- 5.5 Attendance by all exhibitors at the MTS shall be at their own and sole expense.
- 5.6 The SABTC shall from time to time, determine the entry fee for the MTS, which shall be reflected in the MTS Show Schedule.

6 MTS ORGANISING COMMITTEE (“the MTSOC”)

- 6.1 For the purpose of holding, administering and regulating the MTS, the MTSOC is permanently constituted.
- 6.2 Every KUSA affiliated Specialist Bull Terrier Club, in good standing with the KUSA, is an ipso facto member of the MTSOC (“a Member Club”) and shall on request pay an annual participation fee to SABTC, in order to remain a Member Club and participate in the MTSOC.
- 6.3 A Member Club shall be represented by the current chairperson of its Management Committees, or a duly appointed delegate.
- 6.4 The current Chairperson of the SABTC Management Committee is the Convenor and Chairperson of the MTSOC and shall represent the SABTC in the MTSOC and the current SABTC Treasurer of the MTSOC.
- 6.5 Every member club’s appointed delegate must, apart from being members of their Member Clubs, also be members of the SABTC and the KUSA and in good standing with all. The membership fees of Member Clubs’ appointed delegates are due on request.
- 6.6 The SABTC shall annually review and determine all fees applicable in terms of these Regulations, taking into account the projected expense of holding the MTS.
- 6.7 SABTC shall keep proper accounts, reflecting income and expenditure relating to the organising and holding of the MTS.
- 6.8 The MTSOC shall meet to conduct business as often as is necessary, or scheduled at a previous meeting, provided that the

MTSOC Secretary must convene a meeting of the MTSOC within fourteen (14) days from receipt of a written request by any two (2) Member Clubs.
- 6.9 A quorum at any MTSOC meeting shall consist of not less than two (2) Member Club delegates. No meeting of the MTSOC may take place in the absence of the MTSOC Chairperson, or a duly appointed representative. In the event of there being no quorum the meeting shall be abandoned and reconvened at a place and time to be advised by the MTSOC Chairperson.
- 6.10 In the event of the MTSOC Chairperson being unable to attend a MTSOC meeting, or is incapacitated in any way, the SABTC Management Committee must appoint a representative to perform the MTSOC Chairperson’s duties and functions, as set out in these Regulations.
- 6.11 At meetings of the MTSOC a Member Club’s delegate shall have one

(1) vote.

- 6.12 All matters before the MTSOC shall be decided upon by a majority of the votes of those delegates present and eligible to vote. The MTSOC Chairperson shall have a deliberative and a casting vote. The MTSOC Secretary and the MTSOC Treasurer shall have no vote. In the event of an equality of votes, the MTSOC Chairperson may in his sole discretion allow further discussion on the matter or motion at hand and call a re-vote, provided that a round-robin resolution without a formal meeting of the MTSOC shall be equally valid.
- 6.13 The MTSOC Secretary shall take comprehensive minutes of decisions and recommendations made at MTSOC meetings and transmit by e-mail, copies of the unconfirmed minutes to member clubs' representatives, within thirty (30) days after a meeting.
- 6.14 The MTSOC Secretary shall submit all recommendations and decisions made by the MTSOC concerning financial matters impacting on the SABTC to the SABTC Management Committee for approval and/or ratification.
- 6.15 A delegate of a Member Club who is unable to attend MTSOC meetings may for consideration submit advice, topics for discussion, requests or recommendations by e-mail transmitted to the MTSOC Secretary, for presentation and consideration.
- 6.16 In the event of no eligible club wanting to participate in MTSOC for any year, the SABTC may continue with holding the MTS for that year and in its sole discretion appoint any number of persons to be of assistance in holding the MTS. All decisions made in terms of these Regulations shall then be made by the SABTC Management Committee.

7 FUNCTIONS AND RESPONSIBILITIES OF THE MTSOC

- 7.1 The MTSOC is responsible for the organisational requirements to ensure that the MTS takes place properly.
- 7.2 In particular, without derogating from the general responsibility bestowed under these Regulations, the MTSOC:
- 7.2.1 must oversee the draw of the names of at least two (2) but not more than three (3) local judges and two (2) local reserve judges, from a list of acceptable and available local ROM judges, compiled by SABTC in accordance with the provisions of these Regulations, all of whom must be in good standing with SABTC and the KUSA, in accordance with the procedures as set out in these Regulations, to be permitted and contracted to judge the MTS in two (2) years' time, provided that the draw shall take place in public preferably immediately after closing of the MTS where the draw takes place, or at such later and appropriate time as circumstances permit and further provided that:
- 7.2.1.1 no judge whose name is drawn is unconditionally entitled to be contracted to judge the MTS;
- 7.2.1.2 an appointment to judge is subject to approval by the KUSA under its requirements and the execution of a written judging contract with the SABTC;
- 7.2.1.3 a judge whose name is drawn, must remain in good standing with the SABTC and the KUSA, after being drawn, before and after being contracted and until and the day of the MTS.

- 7.3.2 must ensure that all awards made at the MTS are consistent with the classes judged as referred to in annexure A to these Regulations;
- 7.3.3 must ensure that the MTS is conducted in terms of the applicable KUSA Rules and Regulations and this Schedule;
- 7.3.4 must ensure that the Stud Dog and Brood Bitch of the Year awards are made at the MTS, in accordance with the points system provided for in these Regulations;
- 7.3.5 must ensure that the Bellators Breeder of the Year award is made at the MTS, in accordance with the points system provided for in these Regulations;
- 7.3.6 may from time to time, propose specialist foreign Bull Terrier judges to judge the MTS with local judges, provided that such a proposed judge is at least permitted to award Challenge Certificates, or make similar awards to Bull Terriers in such judge's country of residence;
- 7.3.7 may from time to time, invite additional representatives from a Member Club, or other knowledgeable persons or experts to meetings of the MTSOC, for the purpose of presenting explanations, clarifications and views on particular aspects pertaining to the MTS, provided that they shall have no voting powers.

8 LOCAL JUDGES AND SELECTION PROCEDURE

- 8.1 Local judges must meet the following qualifying criteria in order to be placed on the list of judges permitted to enter the draw to judge the MTS.
 - 8.2A local judge must:
 - 8.2.1 be a current member and in good standing with the KUSA and the SABTC and remain so from the time of placement on the list, until and including the day of the MTS;
 - 8.2.2 be, or have been, a breeder and exhibitor of Bull Terriers;
 - 8.2.3 have been a KUSA qualified Bull Terrier Specialist Championship Show Judge on KUSA's Judges Panel for Bull Terriers prior to 1986;
 - 8.2.4 be current Bull Terrier Championship Show Judge on KUSA's Judges Panel for Bull Terriers and who has passed a separate specialisation examination paper on the Bull Terrier Standard at Part II level of the KUSA Judges Programme;
 - 8.2.5 a breeder who has bred in his own name, or his kennel name, a minimum of two (2) KUSA Bull Terrier breed champions;
 - 8.2.6 must have judged a minimum of three (3) Bull Terrier specialist club Championship Shows and comply with the criteria set out in SABTC ROM system for judges;
 - 8.2.7 must be active, or have achieved, one or more of the following:
 - 8.2.7.1 a regular Bull Terrier exhibitor at KUSA licensed Championship Shows, for a minimum of three (3) years preceding the compilation of the judges list;

- 8.2.7.2 a KUSA Championship Show judge of the Terrier Group;
- 8.2.7.3 a committee member of a specialist Bull Terrier club, for a minimum of three (3) years preceding the compilation of the judges list;
- 8.2.7.4 a breeder or exhibitor who has supported the MTS, by entering and exhibiting qualified Bull Terriers at the MTS for a minimum of three (3) years preceding the compilation of the judges list;
- 8.2.7.5 a breeder or exhibitor who has attended the MTS and specialist Bull Terrier Club Championship Shows, for a minimum of three (3) years preceding the compilation of the judges list.
- 8.3 Only the names of local judges whose names appear on the judges list, shall be eligible for the draw.
- 8.4 Having judged the MTS, a local judge becomes ineligible to judge the next two (2) years.
- 8.5 A local judge shall, for a period of twelve (12) months prior to the day of the MTS, refrain from showing, handling or exhibiting a Bull Terrier that has qualified, or could qualify for entry in the MTS and will be shown at the MTS. Such a judge must ascertain on own accord, before handling or exhibiting a Bull Terrier at any show in the 12-month period prior to the MTS, if that Bull Terrier is going to be exhibited at the MTS. A breach of this prohibition shall disqualify a judge from judging the MTS and the MTSOC must replace such judge with a reserve judge.
- 8.6 Local judges drawn to judge the MTS may not judge Bull Terriers at any show for a period of twelve (12) months prior to that MTS. A breach of this prohibition shall disqualify a judge from judging the MTS and the MTSOC must replace such judge with a reserve judge.
- 8.7 A local judge whose name was drawn to judge MTS and whose appointment has been cleared with the KUSA, is required to sign and return to the MTSOC secretary, the prescribed contract within thirty (30) days after receipt thereof. Late return of a duly signed judging contract may result in the judge being deemed unavailable and may be replaced with a reserve judge.
- 8.8 Should the MTSOC, after it is proved to its satisfaction and after due consideration of the facts presented, decide that a judge has breached any contractual obligations, including the obligations mentioned in this Regulation, disqualify such a judge from judging the MTS for a period of up to ten (10) years. An judge so affected shall be afforded an opportunity to make written submissions to the MTSOC, in rebuttal and/or in mitigation to the MTSOC within ten (10) days after receiving a breach notice in this regard, before any the MTSOC makes a final decision to disqualify is made, which decision shall be final and may be amended or revoked only by unanimous decision of the MTSOC.
- 8.9 A contracted local judge shall be deemed to be cognisant of the contents of the judging contract and the applicable disciplinary rules as set out in the KUSA and the SABTC Constitutions.
- 8.10 A judging contract for the MTS includes an obligation to write and submit a comprehensive and complete report, in a format and in accordance with a framework, as prescribed by the SABTC, which shall include comments on the winning exhibits of each separate class, as well as the "Best Mover", "Best Head" and "Best Substance" classes, that they may have judged at the MTS and such report must be submitted to the MTSOC Secretary within two (2) weeks after the MTS. Failure to submit such a report within the said period will be considered a

breach of the judging contract and the disciplinary procedures envisaged in these Regulations may be invoked.

- 8.11 No judge's report shall be published before all three the judges' reports have been received by the MTSOC Secretary, who shall then publish all three the reports simultaneously on the SABTC Facebook page or other suitable platforms.
- 8.12 When drawing the names of local judges to judge the MTS the MTSOC shall conduct this process in accordance with the procedures as set out in these Regulations.
- 8.13 The MTSOC Secretary shall maintain a Local Judges List ("the LJL") in accordance with the criteria set out in these Regulations.
- 8.14 Judges whose names appear in the LJL must confirm in writing by no later than the end of December of each calendar year to the MTSOC Secretary, their availability and willingness to judge the MTS in two (2) years' time, should their names be drawn for this purpose in accordance with the procedures as set out in these Regulations.
- 8.15 The names of local judges eligible to be drawn, shall be placed in a container by the MTSOC Chairperson, who shall request another person, who may not be a representative of a MTSOC Member Club, shall draw at least four (4) names therefrom, eligible to judge the MTS in two (2) years' time.
- 8.16 The names of judges drawn from the container shall be immediately announced, together with the name of the appointed foreign judge, if confirmed by then, under the proviso that their appointments are to be cleared and approved by the KUSA, by the MTSOC Secretary, and they return their duly signed judging contracts within thirty (30) days of receipt thereof. Only after receipt of the signed judging contract shall a judge be deemed to be properly appointed as a judge for the MTS in question.
- 8.17 The MTSOC Secretary shall forward the prescribed judging contracts to the drawn judges within thirty (30) days after their names have been drawn, announced and cleared with the KUSA.
- 8.18 The judges whose names are drawn third and fourth, or fourth and fifth, as the case may be, from the container shall be the reserve judges, in that sequence, to judge in the stead of any of the judges being unable to judge the MTS, or who fail to sign and return their judging contracts within the required time, or who in terms of these regulations become disqualified to judge the MTS, or who have declined their appointment, or who have not been cleared by the KUSA to judge the MTS.
- 8.19 A contracted judge's KUSA clearance must be re-confirmed by KUSA, thirty (30) days before the MTS.
- 8.20 In the event that any judge, becomes incapacitated or otherwise unable to judge the MTS, the MTSOC, in its sole and unfettered discretion, will replace such a judge with a reserve judge.
- 8.21 In the event that the services of any one or both of the reserve judges are required, the MTSOC may waive any of the requirements applicable to eligible judges, in order to ensure that the services of the reserve judges may be obtained.
- 8.22 Should for any reason an insufficient number of appointed or reserve judges are available to judge a particular MTS, or for whatever reason

acceptable to the MTSOC, certain judges or all judges cannot judge a particular MTS, the MTSOC may, subject to KUSA clearance and without following the selection procedure detailed in these Regulations, in its sole and unfettered discretion appoint one or more judges who comply with the criteria as set out in this Regulation, to judge the MTS, or to cancel the MTS for that particular year.

- 8.23 No two judges may judge any MTS simultaneously with one another if they are husband and wife, life partners, co-habitants, or have a direct or indirect employer / employee relationship or have an inter-dependency relationship. In the event of a judge's name being drawn from the container in violation of this Regulation, such judge's name will not be returned to the container and the draw continue until a name of judge eligible to judge the MTS is drawn.

9 FOREIGN JUDGES

9.1A foreign judge invited to judge the MTS must:

- 9.1.1 have been active as Bull Terrier judge during the previous five years, worldwide or in such judge's country of residence; 9.1.2 considered by his peers to be specialist Bull Terrier judge;
- 9.1.3 be or have been a Bull Terrier breeder;
- 9.1.4 qualified to judge at Championship Show level in the judge's country of residence.
- 9.2 For a foreign judge to be invited to judge the MTS in any year, the following procedure applies:
- 9.2.1 A Member Club may propose foreign judge to be considered to judge the MTS;
- 9.2.2 When a Member Club proposes a foreign judge, the judge must indicate whether he is prepared to carry all expenses pertaining to the judge's travel to South Africa and return and provide a judging history and a resume of the judge's judging experience, bearing in mind that the appointment of foreign judges is subject to approval and clearance by KUSA.
- 9.3 Only one foreign judge may judge the MTS in a specific year, provided that a foreign judges who has judged the MTS may not judge the next five (5).

10 JUDGING PROCEDURE

- 10.1 All three (3) MTS judges will be used to judge the separate classes on a rotational basis as set out in Annexure A hereto.
- 10.2 Two (2) of the three (3) judges will judge each class, and no judge may judge more than two (2) classes in succession, the remaining judge acting as a referee, in the case of a split decision.
- 10.3 All three (3) judges shall judge The Supreme Bull Terrier of Southern Africa class, where the majority decision shall prevail.
- 10.4 The sequence of judging will be in accordance with Annexure A hereto and the judges designated "Judge A", "Judge B" and "Judge C", will be determined by a public draw before judging commences.
- 10.5 No conferring between judges is permissible during the judging of the MTS.

11 DRESS

- 11.1 When in the show ring, a handler is required to conspicuously display the exhibit's

allocated number as reflected the MTS Show Catalogue.

- 11.2 Handlers must be suitably dressed for the occasion as befits this prestigious event.
- 11.3 The Show Manager or Ring Steward may deny entry to the show ring to any handler who does not comply with this Regulation.

12 SANITATION

Exhibitors and handlers are required to remove any faeces deposited by their exhibits cleaning of any grooming area they use, who failing to do so, is liable to immediate disqualification from competing in the MTS and discipline by KUSA.

13 CLASSES, PRIZES AND AWARDS

- 13.1 The following age classes, age determined as at on 31 December in the calendar year immediately prior to that in which the MTS is held, shall be judged each sex separately and in the sequence as set out in

- 13.1.1 Ormandy Vase for Dogs under two (2) years of age;
- 13.1.2 Ormandy Jug for Dogs over two (2) years of age;
- 13.1.3 Dog of the Year (competed for the winners of the two dog classes);
- 13.1.4 Ormandy Vase for Bitches under two (2) years of age;
- 13.1.5 Ormandy Jug for Bitches over two (2) years of age;
- 13.1.6 Bitch of the Year (competed for by the winners of the bitch classes);
- 13.1.7 Supreme Bull Terrier of Southern Africa (award competed for by the Dog and Bitch of the Year)
- 13.1.8 Best Coloured Bull Terrier (challenge award competed for by all coloured exhibits: Best Coloured Bull Terrier and Best Opposite Sex)
- 13.1.9 Best Mover (challenge award competed for by exhibits, nominated by judges during the judging of all dog and bitch classes)
- 13.1.10 Best Head (challenge award competed for by exhibits, nominated by judges during the judging of all dog and bitch classes)

13.1.11 Best Substance (challenge award competed for by exhibits, nominated by judges during the judging of all dog and bitch classes)

13.2 The “beaten dog” principle shall apply throughout the judging and award in the dog and bitch and challenge classes.

13.3 Medals and rosettes and designated trophies shall be awarded to all age and challenge class winners.

13.4 In those years when the event is sponsored, the sponsors may make prizes available.

13.5 The trophies listed in the MTS Show Catalogue shall be on display at the MTS, save and except where circumstances do not permit it. No exhibitor may remove any trophy from the MTS venue.

13.6 By entering their exhibits in MTS, exhibitors agree to photographs of winning exhibits together with the trophies that they have won, being taken at the MTS and that the copyright in such photographs shall vest in the SABTC. An official photographer may be provided for this purpose, but, private photographs may be taken under guidance of the Ring Steward.

14 STUD DOG AND BROOD BITCH OF THE YEAR AWARDS

A Stud Dog and Brood Bitch awards and points system as set out in this Regulation will be applicable for each calendar year:

14.1 The Stud Dog and Brood Bitch Trophies shall be awarded annually after the completion of the MTS and the accumulated points for these awards, as stipulated in these Regulations for the specific year, have been calculated.

14.2 These trophies shall be presented to the respective breeder/s of the Stud Dog and Brood Bitch, whose progeny have accumulated the most points during that year, reckoned from 1 January to 31 December, together with points accumulated at the MTS of that year, in accordance with the points system provided for in these Regulations.

14.3 Only Bull Terriers on the KUSA Breed Register and shown in the KUSA area of jurisdiction may earn points for the purpose of these awards. The sires and dams of the dogs that have earned points for these awards do not have to be resident in the KUSA area of

jurisdiction in order for them to be able to win the Stud Dog and Brood Bitch awards and for their breeders to be presented with the relevant trophies and medals.

14.4 Although the Stud Dog and Brood Bitch competition is open to be awarded to any Stud Dog or Brood Bitch worldwide, whether or not they are on the KUSA Bull Terrier Breed Register, only their progeny registered with KUSA and shown within the KUSA area of jurisdiction, may earn points towards these awards, and no other.

14.5 The following points system for the award of the Stud Dog and Brood Bitch trophies applies:

14.5.1 four (4) points for a Champion, accumulated for the year in which Championship status is obtained;

14.5.2 two (2) points for an Ormandy Vase winner;

14.5.3 two (2) points for an Ormandy Jug winner;

14.5.4 two (2) points for the Dog of the Year or Bitch of the Year winner;

14.5.5 three (3) points for the Supreme Bull Terrier winner.

14.6 As proof that a particular Bull Terrier has qualified for the status of Champion, either a Championship Certificate or a copy of a letter from KUSA, stating that such a Championship Certificate will be issued to that Bull Terrier in the same calendar year as the last point towards Championship status was awarded, must on request of the MTSOC Secretary be submitted by e-mail before 31 December of the applicable year, or no points will be allocated to that specific dog or bitch's sire or dam.

14.7 It is the sole responsibility of the owner of a Champion Bull Terrier to inform the MTSOC Secretary in writing and before 31 December of each year, that a particular dog or bitch has been granted the title of Champion during that year and submit either a copy of the Championship Certificate, or a letter from KUSA confirming that the title of Champion has been granted to that specific dog or bitch, before that Bull Terrier's sire and dam will be allocated Stud Dog and/or Brood Bitch points in accordance with this Regulation. In the event of the Bull Terrier being granted the title of Champion after 31 December of the year in which the last points for the Championship status was obtained, no Stud Dog and/or Brood Bitch points will be

awarded for that year. Under no circumstances shall Stud Dog or Brood Bitch points from be carried over to the following year.

- 14.8 Where the progeny of two Bull Terriers have accumulated an equal number of points in the Stud Dog and Brood Bitch awards, the award shall be not be shared the breeders of the said Stud Dogs and/or Brood Bitches, but to break the tie, every major trophy winner will earn an extra point for the sire and dam.
- 14.9 The owners of the respective Stud Dog and Brood Bitch winners shall be presented with medals.

15 **BREEDER OF THE YEAR AWARD**

- 15.1 The merit and achievements of breeders of pure-bred Bull Terriers have never before been formally recognised and rewarded. In order to correct this shortcoming and encourage the breeding of outstanding breed quality and performing Bull Terriers, this award is hereby established.
- 15.2 The award, is bestowed on the breeder who has bred meritorious Bull Terriers shown at KUSA licensed Championship Shows in each calendar year. Consistency and excellence are key elements in determining the recipient of this award. The points system provided for in these rules is accordingly designed to reward consistency and excellence. The breeder who accumulates the highest total of points pursuant to the system, over the course of a specific year will receive the award.
- 15.3 The MTS Organising Committee shall annually recognize and reward one outstanding breeder of pure-bred standard Bull Terriers by awarding the Bellators Bull Terrier Breeder of the Year Award, at the MTS, after all classes have been judged and all points calculated to determine the winner of this award who shall be presented with a trophy known as the "Bella".
- 15.4 Only KUSA members who are breeders of pure-bred Bull Terriers and in good standing with KUSA may gain and accumulate points towards being awarded the Bella.
- 15.5 The accumulation of points for the award are points gained in terms of this Regulation for each calendar year separately, reckoned from 1 January to 31 December, as well as points gained at the MTS for that year, held in February of the next year.
- 15.6 A breeder will gain and accumulate points towards this award from those dogs that are shown at KUSA Licensed Championship Shows that were bred by him/her, as reflected in the KUSA issued Certificate of Registration and Certified Pedigree, regardless of who the owners of such dogs are.
- 15.7 The final point allocation to determine the winner of this award must be made after the annual MTS awards have been made and the

breeder with the most points accumulated will be the winner of the Bella for that year.

15.8 There can only be one winner of this award each year and in the event that there are breeders that have accumulated an equal number of points, the breeder whose dogs have won the highest accolades at the MTS, as determined by the MTSOC on a simple majority of votes, will be awarded the Bella.

15.9 The decision of the MTSOC shall be final when determining the winner of this award in the event of there being more than one breeder with the same total of points accumulated in terms of these rules.
