REGULATIONS FOR THE GERMAN SHEPHERD DOG GRAND VICTOR IGP COMPETITION SCHEDULE 5E (19 B)

(Eff. 01.01.2019)

1. LICENSING AND SHOW REGULATIONS

The Regulations relating to licensing and all other matters to do with Shows as set out in Schedule 3 (Regulations for Championship Shows) and Schedule 4 (Regulations for Non-Championship Shows) of the Constitution of the Kennel Union of Southern Africa shall apply to this Competition so far as they can be relevant to the GERMAN SHEPHERD DOG IGP Grand Victor Trial and as far as they do not conflict with the specific terms of this Schedule 5E (19 B).

2. SCOPE OF THE LICENCE

A GERMAN SHEPHERD DOG Specialist Breed Club in cooperation with the KUSA GSD Liaison Committee hold the GERMAN SHEPHERD DOG Grand Victor IGP Trial. Only one GERMAN SHEPHERD DOG Grand Victor IGP Trial may be held in any one calendar year.

3. ELIGIBILITY OF DOGS

Any GERMAN SHEPHERD DOG may compete for the Title Grand Victor IGP3 Dog which is on the Breed Register of The Kennel Union of Southern Africa, or any other registry approved by KUSA, and whose eligibility does not conflict with the Regulations hereunder or which has not been disqualified or suspended from competition by The Kennel Union of Southern Africa. IGP 1 and IGP2 is open to any German Shepherd type.

4. HOST CLUBS

4.1 An application to host the GERMAN SHEPHERD DOG Grand Victor IGP Trial under the umbrella of one of the clubs defined in section 3 shall be put forward to by the GSD Liaison Council to EXCO. The decision will be subject to the approval of the EXCO. The organization of such a GERMAN SHEPHERD DOG Grand Victor IGP Trial can only be carried out by a specialist GERMAN SHEPHERD DOG club affiliated to KUSA, in collaboration with a GSD Liaison Committee.

4.2 No specialist GERMAN SHEPHERD DOG Club may host a GERMAN SHEPHERD DOG Grand Victor IGP Trial in consecutive years unless the opportunity has not been taken up by any specialist GERMAN SHEPHERD DOG club which has not had or hosted a GERMAN SHEPHERD DOG Grand Victor show in the previous year

5A. QUALIFICATIONS FOR ENTRY

- a. Grand Victor: Dogs qualified in FCI-IGP 3 before the closing date for entries in the Grand Victor Trial.
- b. FCI-IGP2: Dog qualified in FCI-IGP2 or FCI-IGP1
- c. FCI-IGP1: Dog qualified in BH or FCI-IGP1.

Dogs are not allowed to enter in a lower grade than what they have already been qualified in.

5B Titles awarded:

a. IGP3 - KUSA GSD Grand Victor IGP Dog of the Year

6. JUDGING

The judging will be undertaken by a senior IGP Judge, approved by The Kennel Union of Southern Africa and acceptable to the KUSA Liaison Committee and the Club holding the licence for this event.

Helpers will be undertaken by qualified Helpers approved by The Kennel Union of Southern Africa and acceptable to the KUSA Liaison Committee and the Club holding the licence for this event.

If, due to the number of dogs entered, any extra Judge or Judges are appointed then each Judge shall judge ALL the participants in one (1) or more sections (e.g. Group 1 - Tracking, Group II - Adaptability; Group III - Protection). Where more than one (1) Judge officiates the name of each Judge shall appear on any Certificate awarded. In the case of an equality of scores, the provisions of Schedule 5B (2) FCI-IGP, Regulation 3.5.3. The rule of maximum phases per judge as per UDC regulation shall apply.
