

SCHEDULE 05E(30) – REGULATIONS FOR THE KUSA AGILITY WORLD CHAMPIONSHIP TRIALS

(Effective 01.09.2023)

TERMINOLOGY

AWCWG shall mean the AWC Working Group specially appointed to administer the KUSA AWC Trials and selection of the KUSA AWC Team.

FCI AWC shall mean the FCI Agility World Championships.

KUSA AWC Trials shall mean the Event organised for the final selection of KUSA dogs to compete at the FCI AWC Event.

KUSA SAAC shall mean the KUSA South African Agility Championships.

NAgSC shall mean the National Agility Sub-Committee.

SAAC Committee shall be the designated Provincial Council Agility Sub-Committee selected each year to host and co-ordinate the KUSA SAAC Event.

Words importing the singular shall include the plural, words importing the masculine shall include the feminine gender and neuter, and vice versa, unless such interpretation is inconsistent with the context hereof.

1. LICENSING AND SHOW REGULATIONS

1.1 The Regulations relating to licensing and other matters to do with Shows, as set out in Schedule 3 Regulations for Championship Shows and Schedule 4 Regulations for Non-Championship Shows of the Constitution of KUSA, shall apply to this Event so far as they can be relevant to the KUSA AWC Trials.

1.2 The Regulations, as set out in Schedule 05(L) Regulations for Agility Classes and Schedule 05(L) Appendix C Regulations for the Selection of KUSA Dogs to Compete at the FCI Agility World Championships shall apply to this Event, *mutatis mutandis*.

2. SCOPE OF THE LICENCE

2.1 If the KUSA AWC Trials are run independently to the KUSA SAAC (refer to Schedule 05(L) Appendix C), then the AWCWG or any Provincial Council Agility Sub-Committee shall apply for and be issued with a Licence for this Event. The Licence shall be valid for the five (5) rounds, three (3) of which will be Contact Agility and two (2) Non-Contact Agility.

2.2 If the KUSA AWC Trials are held in conjunction with the KUSA SAAC (refer to Schedule 05(L) Appendix D), the SAAC Committee or any Provincial Council Agility Sub-Committee shall apply for and be issued with a Licence for this Event. The Licence will be inclusive of both the KUSA AWC Trials and the KUSA SAAC Events. The Licence shall be valid for the five (5) rounds, three (3) of which will be Contact Agility and two (2) Non-Contact Agility.

2.3 Alternatively, any Club affiliated to KUSA and is eligible to hold either KUSA Non-Championship or Championship Shows may apply for and be issued with a Licence to hold any part of the Event named in this Schedule in conjunction with any KUSA-licensed Show, or separate therefrom, provided it has been approved by the NAgSC.

- 2.4 A Show Schedule shall be submitted in terms of Schedule 3 Regulation 5 or Schedule 4 Regulation 6, where any part of the Event named in this Schedule falls under those Regulations.

3. DATE AND VENUE

- 3.1 The Event shall be held over weekend twenty-four (22) each year, unless otherwise requested by the NAgSC and approved by KUSA.
- 3.2 If the KUSA AWC Trials are run independently to the KUSA SAAC (refer to Schedule 05(L) Appendix C), then the AWCWG or any Provincial Council Agility Sub-Committee shall determine the venue.
- 3.3 If the KUSA AWC Trials are held in conjunction with the KUSA SAAC (refer to Schedule 05(L) Appendix D), the SAAC Committee or any Provincial Council Agility Sub-Committee shall determine the venue.

4. ELIGIBILITY FOR KUSA AWC TRIALS

- 4.1 To enter the KUSA AWC Trials, dogs must be eligible as specified in Schedule 05(L) Appendix C.

5. KUSA AWC TRIALS

- 5.1 All matters pertaining to the administration, documentation, entry, judging, competition format and selection of the KUSA AWC Team and individuals for the AWC Event is as per Schedule 05(L) Appendix C.

6. SPONSORSHIP

- 6.1 The KUSA AWC Trials Event may be sponsored permanently or on an annual basis by any Organisation deemed acceptable to the Federal Council of KUSA. In years when the Event is sponsored, the Event name may include the name of the sponsor. Should either KUSA or any sponsor wish to disassociate themselves from the Event, this may not be done so as to prejudice the holding of the Event in that year or any succeeding years. For this reason, a contract must be drawn up between KUSA and any sponsor establishing the rights and obligations of both should either or both wish to withdraw from association with this Event.
