

K.U.S.A. OFFICIAL SHOW HANDLER FORM

When judging these classes the judge shall consider only:-

The ability of the Handler to control the exhibit;

The ability of the Handler in 'setting up' the dog as an exhibit;

The ability of the Handler to 'gait' the dog at a desirable pace for the judge;

The presentation of the exhibit to accentuate its qualities to the best advantage;

Only normal ring movements are allowed;

The dress and ring demeanour of the handler;

The quality of the dog will not be taken into consideration by the judge.
