# GENERAL INFORMATION TO COMPETITORS AND SPECTATORS

These trials are sanctioned by, conducted and judged according to the rules and regulations of the NATIONAL FIELD TRIAL ASSOCIATION (WCFTC) and the KENNEL UNION OF SOUTHERN AFRICA (CFTC). Reference copies of such rules and regulations shall be available at the trial yenue **Please note:** 

- at the trial venue. Please note:
   Bitches in season are forbidden within the Field Trial precincts.
- Castrated Dogs and Spayed Bitches are permitted to compete in the trials, but may only receive certificates of merit.
- Unregistered dogs will not be permitted to compete in these trials.

All reasonable care will be taken when conducting the trials; however, your attendance at the trials is under the understanding and acceptance that neither the club nor the committee or farm owners or tenant shall in any way be held responsible for any loss, damage or injury by, or to a competitor, official or spectator, or any of the aforementioned animals or property.

Handlers are requested to keep their dogs well away from any livestock, under control and at no time, unless authorised by the steward permitted to run free on any trial ground.

Competitors friends, family and spectators are welcome but must submit to the requests of the Field Stewards, keep 30 meters distant to the rear of the judges, close gates where necessary and not compromise the contestants in any way. All instructions on the conducting and management of the trial will be issued by the Field Steward. While the trial is in progress questions and requests should be directed to the field steward. Do not distract or disturb the judges while the trial is in progress.

No contestant may withdraw his dog from a trial in progress unless he has the permission of the judges. Contestants may speak, whistle or work by hand as he sees proper, however undue noise may result in the judges requesting the dog to be withdrawn.

All contestants are entitled to compete in two (2) rounds in a stake unless they have been previously eliminated. All dogs and handlers called to compete must do so without delay. Being absent for longer than 15 minutes could result in disqualification. A handler may appeal to the judges through the field steward if he/she feels that the behaviour of the competing dog or handler is upsetting his dog.

Please be advised that the Guns appointed to shoot at this trial are in possession of valid Western Cape hunting licenses.

# "THE STANDARD" of Performance of the Pointing Breeds

The performance is one where the very action of the dog denotes an interest in his work.

His work must be full of animation and at all times the dog must be hunting for game in an independent and intelligent manner by using the wind or lack thereof correctly and productively.

His performance must reflect a credit to his breed, and the dog should move with the least obvious exertion for the greatest effort.

The dog must have the desire to hunt and point game with the fire and intensity that makes his work spectacular or, at least, pleasing.

The dog must be adjustable and self-adjusting, controllable and self-controlled.

The dog serves best when saving the hunters legs, and covering the most ground in the least time and he must use the different types of cover and conditions as he comes to them and negotiate each productively, going wide, far, fast, slow, close and/or narrow as the conditions dictate. The dog must do this of his own accord, naturally through training and experience.

The dog's performance must be complete in every respect and must consist of a positive display of manners, game finding, controlling, pointing and holding abilities, staunchness, steadiness and willingness and ability to acknowledge the flush of game and the finds and points of the other dogs by "backing" spontaneously and holding the "back" for as long as is necessary without interference to the staunchly pointing dog or the game being pointed.

He must retrieve the shot game on command in a quick and expeditious manner without unduly disturbing too much ground and should deliver tenderly to hand on land and from water.

The dog must hunt and handle all the accepted species of indigenous game birds, and ABOVE ALL he must be in total harmony with his handler for no other purpose than to give him the opportunity to shoot the pointed game in a manner befitting sportsmen – as there can only be one measure for a good dog and that is how well he serves the gun.

# The dogs under judgement must display all of the elements of the required Standard

Certain **Eliminating or Serious Faults** may result in elimination from the trial, or in exclusion from awards in spite of other performance. Some of these are:

- Lacking ability
- Out of control.
- Running in on flush or shot
- Snatching or snapping at game
- Distinct and deliberate chase (after fur or feather)
- Gunshy (frightened by a shot)
- Blinking (leaving a proven point or retrieve)
- Refusing to back or ignoring a bracemate on point
- Refusal to retrieve or to enter water
- Hardmouth

The farms and farmers property on which the trials are held **must be treated with respect**. AT NO TIME WILL SMOKING BE PERMITTED unless authorised by the Field Steward.



#### STAKES

The **Derby Stakes** are open to all HPR dogs not more than 24 months of age on the date the trial is run. The dog remains a Derby candidate for the whole season irrespective of awards.

The **Maiden Stake** is confined to HPR dogs which have not been placed First, Second or Third in a previous HPR Maiden, Open or Championship Stake.

The **Open Stake** is open to all HPR dogs irrespective of previous awards won.
