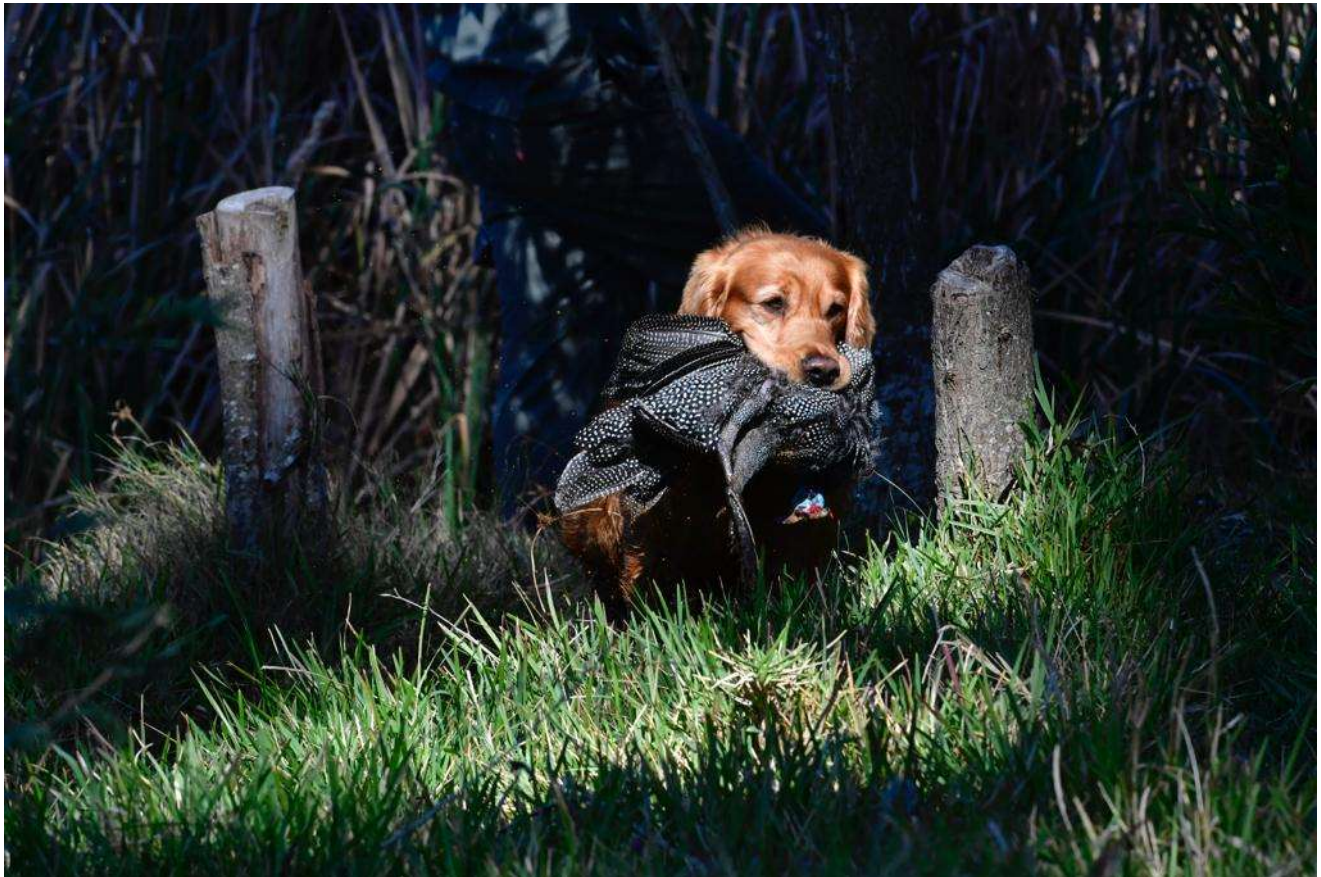

RULES FOR FIELD TRIALS

1. All handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims that may be made in respect of injuries that may arise or be caused by their dogs. All persons attending the trials must consider themselves absolutely under the control of the Officials.
2. All dogs must be registered with KUSA before entry.
3. Bitches in season within the precincts of the Trial are forbidden.
4. Castrated dogs and spayed bitches are eligible for entry.
5. Only those dogs actually taking part in the Field Trial are allowed at the venue.
6. The Regulations relating to licencing and to all other matters to do with Field Trials as set out in Schedule 3 (Championship Breed Shows) and Schedule 4 (Non-Championship Breed Shows) of the Constitution of The Kennel Union of Southern Africa shall apply to Field Trials so far as they can be relevant to Field Trials and so far as they do not conflict with the specific terms of Schedule 5C(1). A copy of the rules will be available at the trials.
7. Anyone on the venue at a Trial openly impugning the decision of a Judge or Judges shall render himself liable to be reported to KUSA under the provisions of KUSA Schedule 1, unless he is availing himself of Schedule A.10.3, of Schedule 5C(1).
8. Conditions attracting immediate disqualification are set out in Regulation 31 of Schedule 3 of KUSA Regulations for Championship Shows (with exception of clauses 31.3.4, 31.3.6 and 31.3.14)
9. If the Club considers the weather and/or venue unfit for the holding of a Trial, the meeting may be held at a different venue or postponed from day to day until the end of the week, when the stakes that are not decided upon may be abandoned and the entry fees refunded, or a fresh draw may be made and a fresh date fixed for the abandoned stakes.
10. The Field Trial Committee reserves the right to change the advertised venue of the Trials if this becomes necessary due to fire, flooding, etc., at the time of the event. KUSA must be informed on the first working day after the field trials
11. If an advertised judge is prevented from filling his engagement for either the whole or part of the field trial, the Field Trial Committee shall have the right to appoint another judge.
12. All dogs born on or after 1 September 2010 must have a microchip certificate.
13. Judges have final decision. Where the Rule or Guide does not cover a particular situation, the decision will remain with the appointed Judges on the day.

LIABILITY

The Committee will exercise all reasonable care in conducting the Trials, but it must be clearly understood that, due to the nature of the sport, competitors, spectators and officials are invited to enter at their own risk and in doing so absolve the Club, Committee and Landowners from any claim whatsoever arising from loss or damage by, or to, any person or property during the course of the Trials.

Please note that in terms of Regulation 5.9 of Schedule 3 of the KUSA Constitution, as applied through Schedule 5C(1) Retrievers, the following notice to exhibitors is a requirement for the KUSA public liability insurance: "All Exhibitors/Handlers are personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dog/s"

NOTICE TO COMPETITORS

All competitors are expected to report to the Field Trial Manager 30 minutes before the start of the Trial to collect their numbers.

At the start of each stake, the Senior Judge shall call all competitors, after which roll call will be held. Any dog that is not reported to the line within 15 minutes of this roll call shall be disqualified from the stake and will not be entitled to any further participation in that stake.

It will be practice in these Trials to summon competitors at the beginning of each series of retrieves to describe the nature of the work to be done. Handlers must ensure that they are present at these briefings.

Training of dogs on the venue is not permitted. Dogs may be exercised in an area designated by the Field Trial Manager. All dogs not participating in a particular retrieve shall be kept on a lead while retrieves are in progress. Any dog which is not in line and which disturbs the work of one under Judge's orders is liable for disqualification.

SAHR POINTS

Other Gundog breeds may enter the stakes, but cannot be placed or receive SAHR points
