

Chairman's Welcome



Due to the nature of this sport, competitors, spectators and offcials are invited to enter the venue at their own risk and, in so doing, absolve the Kennel Union of Southern Africa, the Transvaal Field Trial Association and landowners from any claim whatsoever, arising from injury, loss or damage to any person, animal or property.

General Information

The Club accepts no responsibility for loss, damage or injury to any person or property, however occasioned. The use of the venue has been granted on the premise that it will be left in the same clean and tidy condition in which it is found.

All dogs must be under control throughout the trials. If any dog / person causes annoyance or disrupts the trial, the Field Trial Committee may, at its discretion, request the owner/ handler of the dog or person to remove it from or leave the trial and the venue immediately as appropriate.

Smoking during the trials is strictly prohibited, except where and when permitted by the Field Trial Manager. Spectators are requested to remain in the areas as indicated by the Field Trial Manager and not to wander, as this could be dangerous, as well as spoil the ground to be worked by the dogs.

Spectators are requested to be quiet while a dog is working. Noise can distract both dog and handler.

All persons attending the trials are requested to conform to the above and to ensure that their children do so as well.

What can the competitors expect in the various stakes?

Guidelines for the various retriever stakes have been drawn up to assist judges in setting the courses. They outline what judges can expect from the dogs in each stake.

Handlers must be forewarned however, that these are merely "guidelines" and judges are not bound to adhere to them. [Kindly refer to Schedule 5C(1) - Retrievers for clarification]

RIGHT OF ADMISSION RESERVED!

Definition of Stakes

Puppy Stake: is for Retrievers from 6 (six) months and not exceeding 12 (twelve) months of age, dating from and inclusive of the date of its birth on the first day of the trial.

Junior Stake: is for Retrievers from 6 (six) months and not exceeding 18 (eighteen) months of age, dating from and inclusive of its date of birth on the first day of the trial.

Notice to Competitors

All competitors are expected to report to the Field Trial Manager 30 minutes before the start of the trial to collect their numbers.

At the start of each stake, the Senior Judge shall call all competitors, whereupon a roll call will be held. Any dog and handler not reporting to the line within 15 minutes of this roll call shall be disqualified from the stake and will not be entitled to any further participation in that stake.

It will be the practice at these trials to summon competitors at the beginning of each retrieve, to describe the nature of the work to be done. Handlers must ensure that they are present at these briefings.

These trials are held under Schedule 5C(1) Rules and Regulations of the Kennel Union of Southern Africa.

Training of dogs on the venue is not permitted, except where designated by the Field Trial Manager.

All dogs not participating in a particular retrieve, shall be kept on a lead whilst retrieves are in progress. Any dog which is not in the line and which disturbs the work of the one under Judges' orders, is liable for disqualification.

The Judges' decision is final!

A visitor's guide to field trials

The whole purpose of Retriever Field Trials is to simulate, under competition, conditions which are similar to those encountered in a natural shooting situation. Only too often birds are shot where no working dogs are present. This results in unnecessary suffering and waste. The reason for training Retrievers is to persuade those people that shoot and hunt that the only way to hunt is with a trained dog.

To give you a feel of what the judges are looking for, here is a guide to assist you. Because birds are often hunted in line, it is essential that dogs walk steadily to heel off lead. They must not whine, nor retrieve before being sent by the handler, as this could interfere with the work of another dog.

Good marking of the position of the fall is essential in a retriever, so as not to disturb ground unnecessarily. Judges should give full credit to a dog which goes straight to the fall, picks up and returns the game directly to hand, at a good pace.

The bird must be held firmly but gently by the dog, until it is commanded to release the bird. There must be no evidence of chewing or hardmouth.

On a marked retrieve, that is a retrieve where the dog has seen the fall, the dog should not require handling; the more the dog is handled, the lower the points. On a blind retrieve, where only the handler is given a general idea as to the position of the game, the dog which takes the line offered and requires the least handling, will be awarded the highest marks.

Most important – dogs which show game finding ability and use their noses, should be placed above those which require handling or happen to stumble upon the game.

ELIMINATING FAULTS: Hardmouth, breaking before commanded to retrieve, whining or barking continuously, out of control, chasing other game, failure to enter water, blinking game.


MAJOR FAULTS: Failure to find game, unsteadiness at heel, disturbing ground not related to the fall, poor control.

GOOD POINTS: Natural game finding ability, use of nose, good marking of the fall, quick pick-up and return, good control, keenness, and attentiveness.

It would be wise to train for retrieves that are more difficult than one would expect to face, thus improving the chance of success.



A Tribute to Chris Emin



In his day Chris was a larger-than-life character and was either loved or hated – there were no half measures. Fortunately, I think more people loved him rather than hated him.

He lived life to the fullest and was generous and generally kind.

He had suffered from diabetes for many years and whilst on holiday in the Kruger Park (his favourite place) he went into a diabetic coma and never came out of it. He passed away peacefully on 28th September 2020.

Chris started field trialling almost by accident. He used to go bird shooting with his Jack Russell, Bushy, but was told by Charles Duff that in order to become a fully-fledged member of their shooting syndicate he needed to have a proper Gundog, so he spoke to Peter Kempin who spoke to Judith Buchanan who told him that woman by the name of Jenny Smith had a litter of working Golden Retrievers – hence Polly joined the family in 1996 and field trialling, which he had never heard of until lenny insisted that he enter Polly, took over his life. Wesley also a Golden Retriever or 'space dog' as he was known, was next to join the family, followed by the love of his life 'Boss' who was a black I abrador bred by Garry Emerton. Chris and Boss were a force to be reckoned with in field trials and even though Boss at the age of 21 months had his right back leg amputated, they went on to be the top field trialling dog and handler in the country for 6 consecutive years. I sometimes think that when Boss passed away, part of Chris went with him as it wasn't long after Boss's passing that Chris left us as well. I like to think that he crossed over that rainbow bridge and is frolicking in the fields with Polly, Wesley and Boss and smoking a cigar whilst chatting (or arguing) with so many of our other field trailers who have left us in the past few years.

Rest in peace "Big Man".






