## **TERMS AND CONDITIONS OF CONTRACT**

1. This show is being conducted under the Rules and Regulations of The Kennel Union of Southern Africa.
2. Judging/Helper work is to be conducted to the recognised Regulations and Breed Standards of The Kennel Union of Southern Africa and the Judge undertakes that before judging, he or she will become fully conversant with such Rules and Regulations as may be relevant and appropriate to the Breed Standards.
3. The expenses shown overleaf are subject to approval in advance by the Club conducting the Show.
4. The Club conducting the Show reserves the right to re-allocate one or more of the breeds / groups / tests / grades / classes to another Judge/Helper if an excessive number of entries is received.
5. The Helper is to advise the Hon. Secretary of the Club whether or not this invitation is accepted. If the reply is not received by the Secretary of the Club within **14 - N/A** days of the date of the offer, it will have deemed to have lapsed. (insert number of days)
6. If the Helper's accommodation and / or expenses are not confirmed by the Club within **14 - N/A** days of the date of acceptance it will have deemed to have lapsed and the contract is at an end. (insert number of days).
7. The Club will provide all overseas Judges/Helpers free of charge a copy of the appropriate KUSA Breed Standards and Rules and Regulations applicable to the appointment, prior to the date of the Show.
8. Air and other travel. If a specified mode of travel, including conditional modes of air travel, is required or by a Judge/Helper these should be specified and full particulars of this travel should be given. In the absence of such specification a Judge is entitled to Full Economy return Air Travel on the schedule specified by the Judge. (N.B. the method and responsibility for booking and payment of fares should be clearly agreed upon by the parties to this contract.)
9. Any other terms specific to this contract:
  - a. NOT TO JUDGE THE BREED/S, GROUP/S, GRADE/S, TEST/S, CLASSE/S SHOWN OVER LEAF UNDER THE SECTION MARKED "APPOINTMENT" FOR A PERIOD OF 9 MONTHS – BEFORE THE SHOW DETAILED OVERLEAF WITHIN THE KUSA AREA OF JURISDICTION WITHOUT THE EXPRESS APPROVAL OF THE CLUB OFFERING THIS CONTRACT.
  - b. JUDGES DOMICILED IN THE KUSA ARE OF JURISDICTION MUST BE CURRENT MEMBERS OF KUSA AT THE TIME OF ACCEPTING THIS INVITATION AND AT THE TIME OF JUDGING. A COPY OF HIS / HER CURRENT KUSA MEMEBERSHIP CARD TO BE ATTACHED TO THIS CONTRACT UPON ACCEPTANCE.
